The 2022-2023 Town Budget

Town Government 378 Yes

Board of Education 362 Yes 139 No

\$65.7 Million Passed for 2022-2023 As presented by the Town Council

The \$2,301,603 increase breaks down into \$819,778 or 4.27% increase for the town Government part of the budget and a \$1,481,825 or 3.72% increase to the Board of Education Operating Budget.

"The council has not yet set the mill rate because we are still waiting on some revenues and we want to hold off as long as we can to be sure,"

said Kathy Pugliese town council chair. "We are very cognizant about what is happening with inflation--in terms of energy, food and homes. We do not to put any unneccessary burden on our local taxpayers." However, Pugliese said, the recent revaluation and increase in home prices will result in resideents seeing an increase.

The inflation rate factored into this years budget was 7%. The average inflation rate increase over the past five years was only 1.82%. A7% inflation rate was the largest 12 month gain in 19 years, since June 1982.

Robert E. Lee, Town Manager's Report to Town Council APRIL 4th & APRIL 18th, 2022

Town Council April 4, 2022

Tomlinson Avenue Bridge Project – Road Closure

- The Tomlinson Avenue Bridge Replacement Project has begun. The bridge will be closed to vehicular traffic beginning next Monday, April 11, 2022. Detours have been set up to direct motorists. Motorists are encouraged to avoid the area and seek alternate routes.
- Pedestrian traffic across the bridge will be maintained during the project. The closure is expected to extend through the summer.

Honor Heights Sewer Discussion

- Town staff continues to develop the plans to install sanitary sewers to the 84 homes that are in the Honor Heights neighborhood. The project is proposed as follows:
 - a. Project cost estimate \$1.2M to \$1.4M.
 - b. Source of Funding: Beneficial assessments \$840K (\$10K each residential property) and LoCIP Funding -\$560K (already in place)
 - c. It is proposed that the Town Council allow for the Beneficial Assessments be paid over a 10 or 20-year period at a simple interest rate of 2%.
 - d. The Beneficial Assessment would be due, in full, when a property is transferred/sold.
 - e. According to the Town Attorney, A town can pass an ordinance allowing elderly or disabled homeowners to pay their assessments in other ways. Such alternate payment methods are available only to people who are eligible for circuit breaker, tax freeze, or municipal option tax relief. The ordinance can allow owners to defer any or all payments, to pay only the annual interest charge, or to pay in some other way that the WPCA approves. The outstanding principal must be paid when the property is transferred, or the property owner dies. Optional payment arrangements are subject to annual approval by the WCPA (CGS section 7-253a). (There are currently six property owners in the Honor Heights sub-division that currently qualify for circuit breaker, tax freeze, or municipal option tax relief)
 - f. Property owners would not be required to connect to the sewer system if their current septic system continues to properly function.
 - g. The plan would be for the sanitary sewers to be installed in 2023.
- The first step in the process would be an 8-24 referral to the Planning & Zoning Commission to confirm

- that the expansion is in concert with the Town Plan of Conservation and Development.
- Appraiser be engaged to determine the potential benefit that would accrue to the residential properties if sewers became available. Third, the Plainville Southington Health District should review the plans and provide information regarding the possible "life expectancy" for the existing septic systems. Fourth, a Public Hearing should be held to allow residents to ask questions and provide feedback regarding the proposed project.
- It is recommended that a Public Hearing on the proposed sewer installation be held in May. A recommendation on a specific date will be made at the April 18th Town Council meeting.

ARPA Discussion and Proposed Projects – Library & Recreation

- During the recent budget work sessions, the Town Council expressed an interest in utilizing Coronavirus State and Local Fiscal Recovery Funds associated with the American Rescue Plan Act for the following proposed projects:

 Library Estimated cost \$100,000 and Recreation Department –

 Estimated cost \$40,000 to make up for loss revenue that occurred during the COVID-19 pandemic.
- There is an item under New Business that would schedule the Public Hearing during the April 18th Town Council meeting.

Union Tentative Agreements

- Tentative Agreements have been executed for both the Public Works Union and the Town Hall/Library/ Dispatch Union for a three-year agreement beginning on July 1, 2022 and ending on June 30, 2025.
- The agreements call for 3% salary increases for each of the three years with health insurance employee contributions increasing by 1% in FY23 and 0.5% in the subsequent 2 years.
- There is an item under New Business that would have the Town Council ratify the Tentative Agreements between the two unions.

Tax Sale – April 5, 2022

- Atty. Adam Cohen from Pullman & Comley, LLC will be conducting a tax auction for delinquent taxes and sewer user charges owed on 15 property accounts. The auction will begin at 10:00 am tomorrow (April 5th) in the Town Council Chambers. These 15 accounts were previously authorized by the Town Council for Tax Auction last summer.
- Under the tax auction process, the Town will receive the delinquent taxes or sewer user charges owed (or a portion thereof). The property owners will then have six months

- to make arrangements to pay the amounts owed, plus delinquent interest, to the successful bidders. If the taxes are not paid within the six- month period, the bidders will then take ownership of the properties.
- Those on the list have delinquent taxes and/or sewer user charges ranging from \$9K to \$103K which the Town has not received any payments in several years.

Police Chief Reception

- This is a reminder that a reception to welcome new Police Chief Christopher Vanghele will be held on Wednesday evening (April 6th) from 6:00 7:30 pm at the Plainville Public Library.
- Residents and business owners are welcome to attend and meet the Police Chief. Light refreshments will be served.

Plainville/Southington Health District Update

- The Health District has recently hired two new employees and are now fully staffed. Tanielle Davis has been hired as the Chief Sanitarian for the District. She has a Master Degree in Public Health and previously worked for the Town of Manchester Health Department and the Farmington Valley Health District.
- Julia Burdacki-Krugel is a registered sanitarian who previously worked for the Chesprocott Regional Health District and is a member of the CT Environmental Health Association.
- Regional Health Director Susan Lonczak recently said that the Health District's focus – now that they are fully staffed – that over the next several months, staff will be catching up with restaurant inspections.

Farmington Avenue Tree Planting Update

- The Town Council recently authorized ten trees be replanted on Farmington Avenue. These trees were removed by the State Department of Transportation after being damaged be several recent storms
- The tree plantings are expected to begin this Wednesday, April 6th.

Town Council April 18, 2022

Personnel Policies

- On January 18th Town staff submitted an update of the "Personnel Policy Manual" to the Town Council. This policy had not been updated and reviewed by the Town Council in many years.
- The purpose for the manual is to provide employees and applicants with important information concerning employment with the Town of Plainville, to provide a uniform policy for handling all non-union personnel matters, and

- to handle and clarify situations applicable to all employees including union personnel (unless stated otherwise in a collective bargaining agreement)
- As requested, a "red line" copy of the policy was provided to the Town Council. The Human Resource Director Stacy Buden has proposed updating the Personnel Policy to reflect changes that have occurred in both federal and state law. It has also been updated to reflect some of the changes that have also occurred to benefits that are currently provided to Town employees. The Draft has been reviewed by Atty. Kenneth Weinstock as well.
- Chapter VIII Sec. 2 of the Town Charter states: The Manager shall also cause to have prepared a set of personnel rules which together with any amendments thereto shall become effective upon being approved by the Town Council and filed by the Manager with the Town Clerk. Copies of such rules and any amendments thereto shall be distributed to all members of the classified service.
- Town staff is prepared to answer questions with respect to the proposed amendments to the "Personnel Policy Manual" and a future meeting, if desired.

Farmington Canal Heritage Trail Discussion – Phase 1

- The State D.O.T. is finalizing Phase 1 of the Farmington Canal Heritage Trail in Plainville. Phase 1 will extend from Norton Park south to Town Line Road.
- The present schedule indicates that the design will be completed this December with an anticipated construction beginning next Spring (2023).
- Between now and December, the State will be seeking environmental permits for the project and acquiring several private property rights-of-way.
- The plan is the same as what was presented at a Public Information Session last year. Scott Bushee, the Project Manager for D.O.T. has offered to attend a Town Council meeting if desired.

White Oak Redevelopment Project Update

- The Agreement with Tighe & Bond to provide environmental site assessment, remediation planning and observation and hazardous building materials assessment, abatement planning, and monitoring at the former White Oak site has been signed.
- The maximum fee for these services total \$143,883.90 all of which will be paid by a state grant previously secured by the

- Their first order of business will be to assist the Town in having the site enrolled into the CTDEEP Voluntary Clean-up Program.
- It is anticipated that this work will last approximately 240 days, however, certain portions of the property may become available to the developer during that time to allow them to begin work on the rehabilitation of the existing building.
- Town staff is also finalizing the Land Disposition and Development Agreement with Manafort Newport Realty TY, LLC. It is now estimated that this Agreement will be brought forward to the Town Council for approval next month.

2022 Road Paving Update

- The 2022 Road Bond Program has begun with work being done on the catch basins on the streets to be paved. The plan is to mill and pave 19 streets totaling approximately 3 miles in length. These streets have not been paved in over 30 years.
- The work is expected to be completed by Memorial Day.

Sidewalk Bid Results

- Last Thursday (April 14, 2022) five bids were received for sidewalk replacement. The low bid was submitted by D & P Morais Construction of Ludlow, MA in the amount of \$332,350. The engineer's estimate for this work was \$500K. Town staff is reviewing the bids and will also check references of previous work.
- The project includes the replacement of 7,000 linear feet of sidewalks on portions of Maxine Road, Bernice Court, Florence Lane, Tomlinson Avenue, and Laurel Court. The project will also replace the sidewalk in front of West Main Pizza on East Main Street.
- D & P Morais is a "prequalified construction contractor" through the State of CT Department of Administrative Services for projects up to \$1M. A recommendation to award the sidewalk bid will be made at the May 2, 2022, Town Council meeting.
- The project will be done this summer.

Hemingway Street Drainage Issue

 At the November 15, 2021, Town Council meeting Town staff reported that several residents on Hemingway Street had contacted the Town regarding a drainage problem that was impacting their properties.

- This drainage issue is related to surface and groundwater flowing southerly toward remnants of the Farmington Canal located in Norton Park at the rear of their property. During most of the year, rear portions of their properties are unusable due to flowing and standing water. Some of the water is coming from adjacent Town owned property as well.
- It was discussed that property owners had approached the Town for a solution to this matter. Information gathered indicates that when these properties were developed in the early 1960s, a pipe and swale were installed to address this issue. There are no records of the original installation nor were there any legal documents filed identifying responsibilities for the drainage pipe.
- Over time, it appears sections of the pipe have failed and portions of the swale were regraded. The exact extent of the original installation is unknown; however, historical aerial photographs seem to indicate the installation extended northerly from Norton Park to at least to Willis Avenue.
- The most practical solution to this matter would be to reestablish the original installation with modifications. The first and important modification would be to draft and file the appropriate legal documents outlining responsibilities. Other modifications would involve design elements that would improve the efficiency and durability of the system. It is the engineering department's recommendations the new pipe be constructed of PVC and that the reestablished swale include yard drains.
- Any installation is contingent upon complete agreement of the property owners involved. An easement will need to be secured from every property owner involved in the project. The project can only proceed northerly from Norton Park to the point where the first property owner is not agreeable to an easement.
- A conceptual design review indicates approximately 2000 linear feet of PVC pipe would need to be installed along with approximately five (5) yard drains. The cost for such installation is estimated to be in the range of \$75,000 to \$100,000. Costs could be less if Town staff were to perform the installation.

- Should Town Staff install the system out of pocket costs could just be for the materials needed.
- If the Town Council was interested in providing a solution to this long-standing drainage issue, it would be my recommendation that the property owners directly affected pay for a portion of the construction. The costs could be offset using American Rescue Plan monies as well.
- In November, the Town Council appeared willing to move forward in some way to address this problem.
- If desired, the work to replace this pipe could be done later this summer. Town staff is seeking Town Council thoughts on whether the Town staff should move forward with a plan to address this issue.

Honor Heights Sewer – Public Hearing

- It is recommended that the Town Council, acting in its capacity as the Water Pollution Control Authority, conduct a Public Hearing regarding the extension of sewers into the Honor Hight's Subdivision on Tuesday, May 17, 2022, beginning at 7:00 pm in the Town Council Chambers.
- If scheduled, the Public Notice along with an explanation of the proposed project would be mailed to all the property owners in Honor Heights approximately two weeks before the Public Hearing.
- There is an item under New Business regarding this recommendation.

Additional Appropriation – Capital Improvement Plan

• The FY22 Capital Improvement Plan included funding from the "unassigned fund balance" in the amount of \$869,150. Earlier this year the Town Council approved an additional appropriation of \$600K

- to the CIP.
- Town staff is recommending that the Town Council schedule a Public Hearing for the remaining amount (\$269,150) for May 2, 2022, at 7:00 pm in the Town Council Chambers.
- There is an item under New Business regarding this recommendation.

American Rescue Plan Act (ARPA) Proposed Project

- The list of potential projects to consider for ARPA Funding included the replacement of the chiller at Toffolon Elementary School in the amount of \$300K. The plan is to have this chiller replaced before the start of school in September.
- There is an item under New Business that would schedule a Public Hearing on this expenditure utilizing the Coronavirus State & Local Fiscal Recovery Funds for May 2, 2022, before the next Town Council meeting.

Fair Housing

• The Town is required to regularly acknowledge commitment to Fair Housing. There are three items under New Business that would: 1) adopt a resolution entitled "Fair Housing Resolution"; 2) re-appoint the Town Manager as the Fair Housing officer and authorize him to sign and implement the "Fair Housing Statement"; and 3) authorize the Town Manager to sign and implement the "Title VI Equal Opportunity Statement".

Financial Dashboard

• The Financial Dashboard for the first nine months of FY22 through March 31, 2022, has been provided to the Town Council and has been posted to the Town website.

Town of Plainville On-Demand Bulk Pickup Policy

The Town of Plainville has an on-demand policy for the collection of bulk pickup. Residents who currently have curbside rubbish and recycling collection from the Town can request one bulk pickup per calendar year free of charge for acceptable large items that do not fit in normal rubbish collection. Please visit the Town of Plainville website for a complete list of acceptable bulk items.

Residents will be able to schedule their one bulk pick up free of charge either in the spring or fall. Bulk collection will take place on Mondays during the following periods: today through June 27, 2022 (excluding May 30th, due to holidays).

Eligible residents must call **CWPM**, **LLC** at (860) 793-6721 to schedule a pickup. When calling, you will need to provide your name, address, phone number and a description of the items to be collected. Calls must be scheduled by property owners/landlords; this includes multi-family residents (2-5 units). Calls placed by 3:00 pm Friday can be scheduled for collection on Monday.

Bulk items should be placed curbside no more than 24 hours before your scheduled pickup. Bulk items must not block or create a safety concern for sidewalks or walkways.

Transitioning to Outdoor Exercise Happy spring from Physical Therapy & Sports

It's time to grab those sneakers and head outside for your workout to take advantage of the natural terrain and fresh air for great mental relief. Taking your exercise outdoors is a natural antidepressant and it also challenges your body for an extra boost. Best of all, it's free!

Avoiding Injury

If something feels tight or sore, be sure to gently massage or foam roll the given area followed by stretching for about 2-3 minutes. Do not worry about excessively stretching each muscle. What's more important is a dynamic warm up!

Dynamic warmups involve activating the muscles by performing similar movements to your workout in ways that mimic the body demands about to take place. This should be done for any type of exercise. For example, running is a very common form of outdoor exercise. Prior to running, try performing these movements to improve blood flow, gradually increase heart rate, loosen up your joints Land get the leg muscles ready: Air squats, Hip hinges (preferably single leg),

Walking lunges, Single leg balance with hip

flexion and extension, Light jog in place for a

minute Lastly, do not worry about doing too many repetitions and tiring yourself before your run. 10-20 good repetitions of each will suffice. If you are unsure of your ability to perform any movements, be sure to ask your friendly local physical therapist at Physical Therapy & Sports Medicine Centers of Plainville.

Outdoor Activities

Running is a great form of exercise, but there are plenty of options of outdoor activities that serve as great forms of exercise! Exercises don't have to include weights. Think of it this way, if you are moving your body at a heart rate (HR) slightly elevated than your resting HR, then you are exercising! Some great outdoor activities to get your blood flowing can include: Hiking, Bike riding, Basketball, softball, flag football etc., Kayaking, Yoga. warm up accordingly and start with lower weights, lower reps, or less distance. Remember, muscle soreness is delayed (commonly referred to as "DOMS" for delayed onset muscle soreness). So, you may be feeling great during your workout as our bodies natural endorphins leave us feeling great with exercise but push too hard and you may be in a lot of discomfort for a couple of days after. Prolonged discomfort results in less availability for your exercises!

Also, as your activity increases, your body's demand for fuel and hydration will as well. Be sure to drink plenty of water, and eat plenty of food consisting of protein, healthy carbs, and vegetables. For specific nutritional advice, be sure to ask your Professional PT for a local dietician or nutritionist!

Interesting final tip, if running is your exercise of choice and you are returning to outdoor running, consider your route. Make sure to change your route occasionally or change the direction in which you run. Believe it or not, always running the same path can actually lead to minor injuries over a period of time! This is because roads are designed to have a degree of inclination. This incline allows for proper drainage after it rains. Therefore, when running on the side of the road, one leg is technically 'reaching' more than the other. This can impact your ankle, knee, hip, or low back joints differently than the opposite limb when done excessively and expose the body to increased risk of



Q-1) I am thinking about relocating/moving to a warmer southern state. Can I keep my Medicare Advantage Plan when I move?

A-2) No. Advantage Plans are 'State-based'. If you change your state of Primary Residence, you will need to change your plan. I would suggest that you consider/review the plans in the area where you are planning to move. In Florida, for example, there are a numerous variety of Advantage Plans based on the County you live in. It would be advisable to do some research before you make that permanent change of residence.

Q-2) My 65th Birthday was last month and I didn't enroll in Medicare. I was busy and it wasn't a priority at the time. Now Access Health has notified me my coverage is ending this month. Is it too late to enroll in Medicare?

A-2) You should begin your enrollment in Medicare as soon as possible. You are allowed the 3 months prior to your Birthday month, the month of your 65th Birthday, and 3 months after your Birthday month to enroll in Medicare without being subject to a late enrollment penalty. Go to SSA.gov to complete your Medicare enrollment.

Q-3) I am turning 65 soon, but my spouse is 3 years younger than me. Can she be included on my Medicare policy when I enroll?

A-3) No. Medicare is a personal policy for each person. Your spouse will not be eligible for Medicare until she turns 65; unless she has SSDI.

GRADUATION SEASON '22

It's that time of year again when young adults enjoy the excitement of entering their next stage in life. High School graduation brings a sense of excitement, accomplishment, optimism for all of the graduates. For most, graduation also presents an opportunity to celebrate with a party. Whenever there is a party, the threat of alcohol being present should always be on the minds of parents. Some parents may try to control the consumption of alcohol by allowing their children to drink under their supervision. However, the dangers associated with underage drinking will persist even when adults are present.

Connecticut criminal law penalizes anyone who sells, ships, delivers, or gives alcoholic liquor to a minor, by any means, with a fine not to exceed \$1,500 or imprisoned not more than 18 months or both. The law specifically outlines parents as a person who may be guilty of this crime. If the minor child were ever to be charged with possessing and consuming the alcohol given to them by their parent(s), then the parents could also be charged with a crime. This law extends to any minor, so if you child's friends consume the alcohol you provided, you expose yourself to criminal charges. The application of the law is probably not that shocking for any parent who may be reading this article. The law may not even be enough to deter some from allowing alcohol at a graduation Although, after considering the potential civil liability you expose yourself to you may want to reconsider facilitating any underage drinking.

The potential for anyone to get injured after consuming alcohol is always apparent. When that person is an underage, inexperienced drinker the odds obviously increase exponentially. Therefore, when an adult gives a minor alcohol and that minor injures themselves or others, that adult will be liable for the result. The adult is liable because they set forth the chain of events by supplying the alcohol. Civilly, this opens them up to be sued for the damages they helped create. If the parent or other adult gets a civil judgment ordered against them they may have their wages attached or just about anything they own in order to pay the judgment. Most people would not risk everything they have or may potentially have with someone they trust. So why would anyone risk everything they have to a group of people they may hardly know and have no control over? Regardless of how responsible your children and their friends may be, supplying alcohol to them will always expose you to whatever they do under the influence. Whatever perceived control you may think you have, the reality is that you can never prevent some things. You may end up being liable for something as small as a trip and fall or something as big as a death.

Graduation season is a time for joy and celebration. The last thing anyone wants to think about is an unfortunate incident when they reflect on a graduation. So don't hesitate to tell your kids "No" when it comes to underage drinking. As always, if any of these situations become a reality in your life, consult with a licensed attorney so that you may better understand and protect your rights.

DENTAL HEALTH

Researchers are finding possible links between periodontal (gum) infections and other diseases throughout the body. Current studies suggest that there may be a link between gum disease and cardiovascular disease. In fact, some research suggests that gum disease may be a more serious risk factor for heart disease than high blood pressure (hypertension), smoking, high cholesterol, gender and age. Studies suggest that people who have gum disease seem to be at a higher risk for heart attacks, although no one is certain how this relationship works. Your oral health affects your overall health, but studies that will find exactly why these problems are linked are still underway. Keep your mouth healthy! Gum disease is a serious gum infection that should always be taken seriously. Although gum disease can often show few or no symptoms at all, watch for gums that are red and irritated or bleed easily. There are many new treatments available to control and help reverse gum disease. Remember, gum disease is caused by plaque buildup. Brush and floss regularly to remove plaque that you can't see below the gumline, and remember to schedule regular checkups. If you remove the plaque, you minimize the chance for getting gum disease. If you have any

questions about your oral health, ask your dentist. The current theory is that bacteria present in infected gums can come loose and move throughout the body. The same bacteria that cause gum disease and irritate your gums might travel to your arteries. Researchers are unsure what causes the bacteria to become mobile, but it has been suggested that bacteria can be dislodged and enter the bloodstream during tasks as simple as brushing, flossing or even chewing. Research shows that your risk of developing cardiovascular disease varies according to the severity of gum infection. The worse the infection, the more likely the bacteria are to become blood-borne. Infected gums bleed, making it easier for bacteria to enter your bloodstream. If bacteria become dislodged, the bacteria can enter through cuts or sores in your mouth and can travel to other parts of the body through your bloodstream. If bacteria reach the arteries, they can irritate them in the same way that they irritate gum tissue. This could cause arterial plaque to accumulate, which can cause hardening of the arteries and decreased or blocked bloodflow. Compromised bloodflow to your heart can cause a heart attack. Also, arterial plaque can come loose and travel to other parts of the body. If a blockage occurs in the brain, it can cause a stroke.






Regarding taqiyya, the sanctioned deception of non-Muslims, there are several types, though the term taqiyya is commonly used to cover all of them. PARC offers Adult Life Skills



Plainville ranked 56th in Connecticut for number of booze-related social media posts during the pandemic

Middletown came first in Connecticut for alcohol-related social media posts. South Windsor placed last. Infographic included.

Almost exactly two years ago, Nutmeggers in towns and cities across the state hunkered down, unaware that a global pandemic would render them largely homebound for such a long period of time. Like so many other Americans, Nutmeggers were affected by anxiety - worry about the coronavirus itself, the economic repercussions and what the future may look like in a post-pandemic world. As is the case in more normal times, when people feel stressed or depressed, they reach for the bottle in what they perceive to be a short-term solution.

As the pandemic well and truly set in, two things happened: people began to consume more alcohol, and they spent more time on social media - their primary channel with the outside world. In 2020, state officials introduced a crowd-pleasing salve: a temporary legalization of togo alcoholic drinks from bars and restaurants. As the months progressed, the term 'Quarantini' entered our mainstream lexicon, becoming a catchall term for any cocktail made during lockdown, and soon social media was flooded with alcohol-related content. In one study, Nutmeggers' favorite homemade cocktail during the pandemic was found to be a Coquito.

National rehab directory, Rehabs. com, commissioned a study in which the 100 largest towns and cities in The Constitution State were ranked for their number of alcohol-related Instagram posts over the course of the pandemic. The researchers analyzed 5,000 Instagram posts starting from March 2020 - the unofficial start of lockdowns for most states - to identify how many were related to alcohol or being drunk. The results reveal

which town/cities posted about it the most, which could possibly indicate a problematic relationship with alcohol.

Rehabs.com made some interesting discoveries: the first being that Middletown, which has a population of 47,717, came in the number one spot with 411 alcohol-related Instagram posts (per 5,000 posts) during the pandemic. This represents 8.22% of all Instagram posts in that city during that period. This might not be all that surprising when you consider that Middletown is in Middlesex County, which has among the highest amount of excessive drinkers in the state at 23%, according to County Health Rankings. This places it in the top 15th percentile of the whole country and is higher than the average excessive drinking rate in Connecticut of 20 percent.

Coming mid-table was Tolland with 156 alcohol/drunk-related posts representing 3.12% of all posts during that time.

In 56th place came Plainville, in which there were 141 Instagram posts related to alcohol or being drunk. This represents 2.82% of all posts of its 17,525 residents.

And, positively saintly in last place, was the community of South Windsor, which has a population of 26,918. It clocked up just 22 alcohol/drunkrelated posts equalling a minimal figure of just 0.44 percent. And this is despite being located in Hartford County which, according to the County Health Rankings, has an excessive drinking rate of 19 percent - just below the state average.

While the term "alcoholism" is clinically ambiguous and out of use, Rehabs.com have included below some signs to be aware of that that are indicative of problematic relationship with alcohol:

Difficulty controlling one's level of alcohol consumption.

Wanting to decrease or stop drinking alcohol but being unable to do so.

Developing a higher tolerance for alcohol and needing more over time to reach the desired effects.

Experiencing alcohol cravings when not drinking as well as withdrawal symptoms such as sweating, shaking and nausea.

Facing personal problems at home, work, or school due to alcohol use.

Inflation: The Cruelest Tax

The late economist Milton Friedman stated that, "inflation is the cruelest tax." It is most often the result of governmental policies and impacts every segment of society and the economy.

Currently inflation is officially running at 7.9% but for many costs are up much higher. While some politicians attempt to lay the blame for the current bout of inflation on supply chain issues creating shortages and corporate "greed" at its core the inflationary spike hitting Americans in their pocketbooks is the result of American fiscal policy, specifically "Quantitative Easing," as well as other economic policies.

"Quantitative Easing"

is simply the expansion of the available money supply. In 2000 the federal money supply was \$4.9 trillion, twenty years later in 2020 the federal money supply was \$18.8 trillion. The effect of the expansion of the money supply can be seen in the price of gold. In 2000 the price of an ounce of gold was approximately \$400, today (4/11/2022 at noon) it is \$1,953.26. The rise in the price of gold has mirrored the expansion of the United States supply of currency and reflects the laws of supply and demand. As supply increases the price drops, in this case as the supply of money increases each dollar's purchasing power decreases. This economic relationship has existed since the creation of currencies. In the Middle Ages Kings often would try increase their holdings in gold by debasing the coinage, using less gold (or silver) to make their coins thus keeping more for themselves through a backhanded tax on those holding, or buying and selling goods using the "Coin of the Realm." The result was always the same, the actual purchasing power of each "new" coin was less than the older coins which contained more gold. Debase the coinage and inflation would follow. "Quantitative Easing" is merely the modern equivalent of this medieval financial policy that is ruinous to the economy.

The current bout of inflation has coincided with serious supply issues created by the economic shutdowns enforced by governments in reaction to the Covid-19 pandemic and labor shortages in key industries like agriculture and food production which are historically lower paying than other industrial trades. The USDA is predicting 4.5-5% increases in food cost this year. However, what is not covered in that estimate is the impact of shortages in certain foods, especially shortages in generic brands, are having on the consumer. For the working class, the working poor, and those on fixed incomes when generics are unavailable their real cost skyrockets beyond inflation.

For many the Dollar Tree, Family Dollar, and Dollar General have become part of their grocery shopping routine through the lack of larger supermarkets where they live and their array of lowcost items. The increase of Dollar Tree items from \$1 to \$1.25 is a 25% jump in price. It is not "transitory" nor "temporary" as many Washington D.C. politicians and political pundits have been claiming. It is an economic drain on the consumer's pocketbook. Given the rise in food staples and energy it is also a cost that cannot be avoided. The price of going to a concert or sporting event increases one can avoid that cost by simply not attending those events. Food and energy are necessities that must be purchased, the cost will be borne by the consumer.

The idea being bandied about in Washington to deal with inflation by spending more money, more "Quantitative Easing," will not help the American consumer, it will only spur on more inflation. Expand the money supply with more dollars, each dollar buys less just as it was in the Middle Ages when Kings decreased the amount of gold in the coins, each coin lost purchasing power. The laws of economics are laws for a reason, no amount of political spin will change economic reality. While inflation is technically not a "tax" in the sense of directly paying the government it is the product of national fiscal policy to spend more than tax revenues brought in and functions as the cruelest of political policies as it robs the citizenry of the hard won fruits of their labor by devaluing what each person has earned.

Wheeler has received a \$100,000 gift supporting its campaign for a new health center in Bristol, as well as numerous programs benefiting students at Northwest Village School in Plainville.

The gift is from the estate of Hall "Cap" Adams, Jr., a longtime philanthropic investor in Wheeler's work. I'm More interested in the real victims. People who have been screwed over by the system. Plainville's First Monuments

Monuments have been being built by humans since they began to walk upon the earth. From Stonehenge and the Pyramids to present day, it always has been important for us to mark the location of a special person, place or event to be remembered. One memorable event that took place here on the Great Plain of Farmington was during the Revolutionary War.

During late 1767 an Act was passed that gave the local towns guidelines for the placement for the mile markers or monuments. They were to be placed on the right side of the highway, a distance of 39 miles between the Hartford Courthouse and the New Haven Courthouse. They were marked at the top with an H for Hartford, then roman numerals, and an M for the number of miles to Hartford.

In June of 1781 three thousand French troops under General Rochambeau arrived at New Haven Harbor. This colorful entourage probably followed the markers as they marched upstate through Plainville as was the custom of the day. The troops made an encampment near the Farmington border while on their way to Wethersfield where the Yorktown campaign was planned. This event created a well-traveled road they called the New Haven to Hartford Turnpike. It was also known as the College Highway as it ran between two college towns. When the State took it over it became Route 10.

In our village, three mile markers were placed along the highway, but through the years they were forgotten and only one marker (XIV) was left standing at the time of our Centennial in 1969. Ruth Hummel formed The Plainville Historical Society and one of her first projects was to seek, find and replace the monuments. She found number fourteen near the Southington town line damaged and it was reset.

The other two monuments were still missing so she wrote an article in the newspaper about the missing markers. Success was finally accomplished when mile marker X111 was found holding up a camper at a local garage. Then in the spring of 1971 number X11 was found sleeping in a Wethersfield state highway garage. With much celebration. monument marker numbers 12, 13 and 14 proudly stood again to mark the miles along the road. If you would like to learn more about the mile markers contact the Plainville Historical Society.

Plainville's **Civil War Monuments**

While still a part of Farmington the first monument placed in our village was a wooden Civil War memorial erected at the West Cemetery. It was dedicated to the fallen soldiers in 1865 at an Independence Day Celebration where Mr. Tomlinson suggested that we should have "a more suitable shaft commemorating the 70 men who served in the Civil War." He made an initial donation and encouraged others to follow. He quickly raised \$121.41 at the celebration and founded the Connecticut Monument Association.

On November 25,1875 the monument money was received by T. P. Strong, Chairman of the Association, and deposited in the Farmington Savings Bank. It was then renamed the Plainville Soldiers Monument Association. An appeal was made to the citizens to contribute \$1.00 to be a member. Unfortunately the list of original donors was lost when a fire engulfed the Plainville Railroad Station where the list was kept. Years went by as the money lay dormant due to a poor economy.

Then in 1903 the Newton Manross Post of the Grand Army of the Republic took up the monument project. They appealed to the Connecticut General Assembly to pass a bill making the town Selectmen custodians of the funds so they could build a monument. The veterans then asked the Selectmen to call a meeting to authorize and award a contract. A few hundred dollars had increased with interest to \$2,200. A place for the monument was found when the railroad company agreed to lease to the town a plot of land called Central Square where the Woman's Christian Temperance Union had already leased land to erect a drinking fountain. Central Square, where the Municipal Center now stands, then became our first memorial park.



Marriage Makes You Happier, Better, And More

Fewer Americans are interested in seeking out a life partner even though data shows that marriage often leads to flourishing.

New polling from Pew Research Center suggests that more than half of single U.S. adults, 56 percent, are not interested in romantic relationships or even going on casual dates. As noted in the survey results, that number is up six percentage points from 2019.

Only 32 percent of those Americans who are looking for dates say they want committed relationships. Approximately 16 percent say they are content to stick with casual dating.

Those men and women who do enter the dating pool are less and less satisfied with their prospects. At least 63 percent of U.S. adults claim that dating has become more difficult, especially during the last two years. Seven-in-ten Americans say their dating lives are not going well at all.

The poll attributes part of this strain to the "pandemic" — a.k.a., government-mandated lockdowns and isolation encouragement from health bureaucrats. In reality, Americans' perceptions that dating has grown harder is a trend that's been on the rise for the last decade.

There's also an age gap when it comes to how different generations view the challenge of dating. Approximately 71 percent of adults younger than 30 years old are say dating is tougher now, a statement with which 58 percent of adults above 30 years of age agree.

On the flip side, 22 percent of single adults younger than 30 say the pandemic sparked their interest in entering a serious relationship while only about 10 percent of those older than 30 say the same.

Marriage is one of the greatest measures of flourishing for U.S. adults. Fewer Americans are choosing marriage over casual dating and cohabitation but those who do tie the knot report lower divorce rates and higher general happiness.

"Compared to Americans who are unmarried, married Americans are more likely to report that they have a satisfying social life and a larger group of close friends. They also say they are more satisfied with their personal health than their single peers do," the American National Family Life Survey notes.

Married couples who add kids to their families are even more satisfied. Even during the pandemic, married couples with children were less likely to report sadness or unwanted weight gain than any other group.

In addition to bringing lovers together, marriage offers a wide range of physical, mental, financial, and spiritual health benefits. Recent reports of increasing anxiety and depression in Americans, especially among younger age groups, signal how much our instant-gratification, anti-commitment culture damages young people and leaves them lonely. When fewer U.S. adults are even interested in entering the dating pool that would lead to a committed relationship and possibly marriage, it hurts their chances of thriving.

Gun Rights After New Law

Georgia's state assembly passed a bill protecting carry rights. Georgia's move means half the states now have constitutional carry laws. Gun rights are spreading across the US. Georgia's General Assembly passed a law recognizing carrying a firearm as a constitutional right that doesn't require a permit. The Georgia Constitutional Carry Act went through easily in a 94-57 vote.

In a press release, The National Rifle Association said Georgia's addition brings the number of constitutional carry states to 25 – halfway to the

NRA's goal.

The shift represents a massive change since 2011 when Vermont was the only state allowing permitless concealed carry.

Democrats and gun control advocates fiercely opposed the new bill. Claiming the state had refused more than 2,500 carry permit applications, showing the need for the permit system.

Still, a majority of the state's legislators – and the governor – disagree. Now, Georgia residents can exercise their constitutional right to bear arms without

first obtaining the government's permission.

GOP State Seeks To Completely Outlaw Abortion -Liberals In Full Freak-Out Mode

The Texas Heartbeat Bill caused a nationwide uproar from baby-killing liberals and far-left progressives, so there's no telling the level of insanity this new bill will cause.

Oklahoma's House of Representatives passed a bill earlier this week that would ban nearly all abortions in the state. If it is signed into law it would be the strongest pro-life law in the nation.

The law, HB 4327, would outlaw doctors in the state from performing any abortions unless the life of the mother is at risk. Private citizens could also sue doctors or others in the state in violation of the law for up to \$10,000.

The bill next moves to the state's Senate where it will likely pass under the GOP-led majority. The governor has not yet stated whether he would sign the bill into law. If enacted, the bill is set to go into effect on November 1, 2022.

The proposed law would surpass even the recently enacted Texas law as one of the strictest abortion laws in the country, banning nearly all abortions after the point of conception instead of at the detection of a fetal heartbeat. In 2021, the new legal action in Texas banned abortions after the detection of a fetal heartbeat, generally at about six weeks of pregnancy.

The Supreme Court allowed the Texas law to stand, leading other Republican-led states to begin pursuing similar legislation.

"House Bill 4327 does not end abortion, but it will induce compliance because no abortion provider will violate it and risk a lawsuit," said bill sponsor and Republican Rep. Wendi Stearman.

"The legislation also includes an exception for women who seek an abortion due to rape, sexual assault or incest so long as the crime has been reported to law enforcement," the report noted.

Oklahoma is among several GOP majority states to pursue new abortion restrictions this year. Tennessee Republican lawmakers introduced a new abortion restriction law last week modeled after recent legislation in Texas that would ban most abortions.

The Volunteer State already has some of the strongest pro-life laws in the nation. The new bill would further limit abortions, allowing private citizens the ability to file civil lawsuits against those who perform an abortion

"This bill is modeled directly after the legislation passed in Texas last year. Abortions, since that bill has been passed, have dropped 60% in Texas," Republican Rep. Rebecca Alexander, the bill's sponsor, told a House subcommittee.

The Idaho House of Representatives also passed a new bill last week that bans abortion after six weeks of pregnancy. **Cue the liberal shrieking!**

Plainville youth wins citizen award

Local youth Michael Ahern will be presented with the 2022 Citizen Honors Award for Youth Service from the Congressional Medal of Honor Society.

This honor will recognize his efforts to raise more than \$30,000 for wounded veterans through "Scoops for Troops."

The Congressional Medal of Honor Society was established by the 66 living recipients of the Medal of Honor. The "Citizen Honors Awards" program was launched in 2007 and "reflects the mission of the Society to promote the principles behind the Medal of Honor and to show that they are relevant to all Americans."

The Community Service Award recognizes a community-based organization for its "exceptional impact or mission in supporting our nation's military service members and families."

According to a statement from the Congressional Medal of Honor Society, Ahern was selected following a national

search for individuals and an organization whose "service or act of heroism greatly distinguished themselves."

"Michael's passion and commitment reflect great credit upon himself, his family, and the state of Connecticut," the statement read.

In 2019, at the age of 9, Michael Ahern

founded "Scoops for Troops" to pay for kids' ice cream while their families were on vacation at Travis Mills Foundation's retreat in Maine. The Travis Mills Foundation helps post-9/11 veterans who have been injured in service to our nation – many who have lost one or more limbs – overcome their physical obstacles and enjoy well-deserved

rest and relaxation.

Ahern quickly exceeded his initial, \$400 goal and decided to go for a larger goal of sending families on

an all-expenses paid vacation to the retreat. Last year, he presented a \$31,733.66 check to Travis Mills in person, which covered the expenses for eight families.

"Meeting Travis in person was amazing," Michael Ahern said. "I also got to meet some of the families up there."

Ahern will be traveling to Charleston, South Carolina to be formally presented his Community Service Award by a Medal of Honor recipient on July 20. Michael Ahern's father, Scott Ahern, said that it was "amazing" to see how his son's hard work was being recognized.

"Michael was speechless when we found out," said Scott Ahern. "He was absolutely ecstatic."

Scott Ahern said his son intends to continue fundraising to support veterans.

"He wants to raise at least \$30,000 every year and his goal is to hit a \$500,000 before he goes to college," he said.

To that end, "Scoops for Troops" has been registered as a 501(c)(3) non-profit organization.

"Our work is very important and we want to keep going," said Michael Ahern.

This year, Michael Ahern recently helped serve breakfast to Vietnam War veterans in Maine. He will also be serving ice cream at the "Miles for Mills 5K" over Memorial Day weekend, which also supports the Travis Mills Foundation. Scott Ahern said that this event attracts more than 5,000 people from all over New England.

Ahern also plans to hold another "swimathon" fundraiser in Connecticut this July. Last year, the "swimathon" was held at Shuttle Meadow Country Club in Berlin.

Swimmers pledged to do 100 laps each from 8 a.m. to noon.

"We're hoping that Travis Mills will come down for the swimathon," said Scott Ahern.

"Scoops for Troops" came about when the Ahern family was visiting their vacation home in Maine. Over the years, they saw the Foundation's retreat being built. Then, in 2018, on the Fourth of July, the family watched a parade in Belgrade, Maine, where Michael Ahern spotted a soldier who had lost both of his legs across the street.

"I went over to tell him 'thank you for your service," Ahern said. "Ever since I was 3 years old, I was really interested in the Army and what they do. I would always say 'thank you for your service."

This event sparked Ahern's desire to give back to those that have served.

From the Plainville Animal Control Desk:

In the dark of night on April 5 two cats were left outside the town pound in a pet carrier. They were found safe when the staff arrived for work in the morning. A note explained that the owner was very ill and could no longer care for them. The note did include their names, no other information. It is so helpful to have some information about an animal when it is placed for adoption. Its name, any diet requirements or health issues, shot and spayed status, and age helps to get them more quickly resettled. These are good boys, both handsome, friendly, and obviously they care for each other. One was terrified, but is adjusting. There will be no problem placing them in a good home. All is well and they are lucky.

We need to have a serious discussion about this. Clearly, it is not safe to abandon any animal on the grounds of the pound, or anywhere else, at any time but especially not after dark. The pound is located in a wooded area near a wild life sanctuary and the dump. We know that Plainville has a nocturnal wild animal and predatory bird population. Any cage, or worse, a cardboard box would make short work for a pack of coyotes. A huge predatory bird could frighten a small animal to death. It is not necessary to reach such a desperate decision to do this in Plainville. If you cannot keep your pet, whatever your situation, your Animal Control Team stands prepared to help you.
