#### March 1, 2018 Road Bond Bid – Catch Basins

- On February 22nd the Town received nine bid proposals for the construction, repairs and adjustments of catch basins on various streets as part of the road bond program.
- The low bid was provided by Jones Construction of Unionville in the amount of \$38,800. References have been checked and Town staff is recommending that Jones Construction be awarded the bid in the amount of \$38,800.

## Tax Fixing Agreement – Six Mile Holdings, LLC

# DISTRICT PRESCHOOL REGISTRATION FOR THE 2018-2019 SCHOOL YEAR

The Plainville Community Schools Preschool Program will begin accepting registrations on Monday, April 2, 2018 for children who reside in Plainville with parents or guardians, who will be age 4 by December 31, 2018 and who were born between January 1, 2014 and December 31, 2014. The program is designed to prepare students for transition to kindergarten at age 5. Our eight classrooms will follow the district calendar and school hours for all three elementary schools, which is 8:50 AM to 3:30 PM. Due to the expected construction at Wheeler Elementary School, the preschool classrooms at Wheeler will be relocated to Linden Street School for the next two years. Tuition for this program will be \$2000 per child for the year with options for quarterly or monthly payment plans and reduced fees for families who are eligible for free or reduced lunch. Transportation will be provided based on district transportation guidelines for our elementary schools. Students who live outside of the designated busing zone for their school will not be provided with transportation

Registrations will be accepted at each neighborhood preschool on a first-come, first-served basis. \* Use cold water heated on the stove or in the microwave instead of hot water from the tap to perpare baby formula and convenience foods that call for hot water. Hot tap water can pick up metals from plumbing pipes or solder.

\*Consider the source. The safety of bottled water and tap water initially depends on the source of the water. Monitoring and testing ultimately determine the quality of the finished product. The 1996 reauthorization of the Safe Drinking Water Act requires that bottled water be monitored in the U.S. and tested in the same rigorous manner as tap water.

\*Support protection projects for wetland areas near your source of drinking water. These areas help keep our water clean.

A laser is an instrument that produces a very narrow, intense beam of light energy. When laser light comes in contact with tissue, it causes a reaction. The light produces by the laser can remove or shape tissue.

#### **Are Lasers Used in Dentistry?**

Yes, lasers have been used in dentistry since 1990. Lasers can be used as a safe and effective treatment for a wide range of dental procedures and are often used in conjunction with other dental instruments.

#### Dental lasers can be used to:

Remove small cavities without anesthesia. Reduce the discomfort of canker and cold sores.

Expose partially erupted wisdom teeth.

Remove muscle attachments that limit proper movement.

Manage gum tissue during impressions for crowns or other procedures.

Remove overgrown tissues caused by certain medications. Perform biopsy procedures.

Remove inflamed gum tissues and aid in the treatment of gum disease. Remove or reshape gum and bone tissues during crown lengthening procedures.

Help treat infections in root canals.

Speed up tooth whitening procedures.

#### What are the Benefits of Using Dental lasers?

There are several advantages. Dentists may not need to use a drill or administer anesthesia in some procedures, allowing the patient to enjoy a more relaxed dental experience. Laser procedures can be more precise. Also, lasers can reduce symptoms and healing times associated with traditional therapies; reduce the amount of bacteria in both diseased gum tissue and in tooth cavities, and control bleeding during surgery.

#### **Are Dental Lasers Safe?**

If the dental laser is used according to accepted practices by a trained practitioner, then it is at least as safe as other dental instruments. However, just as you wear sunglasses to protect your eyes from prolonged exposure to the sun, when your dentist performs a laser procedure, you will be asked to wear special eyeglasses to protect your eyes from the laser.

#### How can I be sure my dentist is properly trained to use a laser?

Ask your dentist questions about the extent of his or her laser education and training. Make sure that your dentist has participated in educational courses and received training by the manufacturer.

How will I know if treatment with a dental laser is an option for me?

Ask your dentists. Although the laser is a very useful dental instrument, it is not appropriate for every dental procedure.

Stewart officially enters race

for Governor

NEW BRITAIN — Standing in Founders Hall at her alma mater, Central Connecticut State University, on Monday, Mayor Erin Stewart formally announced her candidacy

for governor."Go, Erin, go," supporters chanted after she declared that she's in the race, adding her name to those of more than a dozen other Republicans. After her announcement, Stewart talked about the importance of a new generation of leadership in Hartford and called the 2018 election a "tipping point" for the state. As a 30-year-old Republican woman in public office, she touted herself as a standout candidate. "If you're looking for a candidate that's going to fit in a certain ideology, I'm probably not the candidate you're looking for," Stewart said. "On many issues, especially budgets and finances, I'm very much a conservative. On other issues, my positions are more moderate or liberal, and I stand by them. It's what I truly believe and I'm not going to

While briefly discussing some of her platform points, Stewart referred to CCSU and the state's other institutions of higher education as "ground zero" for Connecticut's future. "We have to make sure that we're keeping our young people here and providing opportunities for them," Stewart said. "Creating jobs from under our economy

change them just to win a campaign."

and creating a talent pipeline from our state universities to new and exciting ventures is what will fuel our new economy and keep our millennials here."

Stewart acknowledged she is facing a lot of competition. More than 20 candidates have formally declared their candidacy, with more than a dozen of them Republicans. "There have been many people that have been in this race for a lot longer than I. I understand that I'm a little late to the party," Stewart said. "But Connecticut needs more than slogans right now. We need more than candidates who say they have the medicine for our troubles if only we'd elect them. Connecticut needs a fresh voice and a new vision for our state's future, one that brings us together rather than divides us."

Stewart said she intends to qualify for the state's public financing election system, the Citizens Elections Fund. To qualify, Stewart needs to raise \$250,000 in contributions of \$100 or less from Connecticut residents. Stewart declined to give a firm number, but siad she's been raising

money at a steady pace and is confident she can hit the \$250,000 threshold. She said her fundraising totals will be updated April 1, the quarterly filing deadline and three days before the Connecticut

To participate in the party's fifth debate, set for Wednesday, April 4, candidates must have formally declared and must have a significant campaign war chest. "To say that I would have \$175,000 in the bank by April 4 is a little unreasonable," Stewart told reporters following her announcement.

The debate will be held at New Britain High School, and Stewart said she "absolutely" thinks she should be included even if she hasn't hit the \$175,000 mark yet. And if not, we'll be standing outside with 200 of my closest friends to rally for support onstage," Stewart said.

The Connecticut GOP convention, at which 1,000 delegates will vote to endorse a candidate, begins Saturday, May 12. Any candidate who earns 15 percent of those votes will have the opportunity to force a primary, which would be on Tuesday, Aug. 14.





Each match begins with a 15-second autonomous period in which robots operate only on preprogrammed instructions. During the remaining 2 minutes and 15 seconds of the match, the teleoperated period, student drivers control the robots. Teams on an Alliance work together to continue to control their Switch and the Scale. They can also trade in their Power Cubes for Power Ups. During the final 30 seconds, teams work together to Climb to Face the Boss. Team Alliances are seeded in the Qualification tournament using ranking points which are awarded based on a combination of their Win-Loss-Tie record.

The Digital Devils were picked by 2 other teams to compete in the playoff matches. During the playoffs the team faced tough competition and battled through to the semi-final matches. Although faced with mechanical break downs and programming difficulties, the Digital Devils pulled away with a Championship Victory. The Digital Devils advisors are Plainville High School faculty members David Gaignard and Mark Chase.

The Digital Devils' next competition is scheduled for April 6-8 at Hartford Public High School. All events are open to the public.

Unfortunately you have to hear everyone of their stories at least twice except for the guy at the end of the table that asks his wife, "What did he say?"




At least if you're near someone with kids, that are making a lot of noise, a stern look usually gets the parents to tell them to hold it down.

grandkids will never ever have a chance to see, use or play with. I am not sure how we survived doing some of the things we did. My friends and I would meet in the garage near the kerosene tank and smoke cigarettes. We knew no one would ever think that we would be in there. We never thought that we could have been blown to pieces. Back in the day, we used to be able to smoke on airplanes. It is a wonder we didn't die from second hand smoke. We rode around in convertibles with no seat belts and played records on a record player in the car that skipped every time we hit a bump.

We walked ½ to 1 mile to school in 2 feet of snow. There was no cancellation of school unless there was a full blown blizzard of the century. In the summer, the schools had no air conditioning. If it was warm, the teacher used a long stick to open the windows and the room filled with flies and heat. She also used that stick to rescue you if you got into the deep end of the school pool and couldn't swim. She would have you grab the pole. (I know from firsthand experience.)

In the summer, we rode bikes with no helmets. We followed the ice cream truck while ringing our bike's bell. When is the last time you saw or heard an ice cream truck or a bike's bell. We caught fireflies in jars, picked blueberries and sold them by the jar and spent the whole day outside if we could.

We played hopscotch, kickball and tag in the street. When cars showed up, we moved and then returned to the street once they passed. One of our favorite things to do was to play double dutch. You never even see children jumping rope these days. We would cut part of Grammys clothesline to jump with. We played outside until dark. We were bitten by hundreds of mosquitos but never heard of Lyme disease. We played with every toy on the market. There was no such thing as a recall on a toy. You just played with it until you broke it or tired of it.

When we were bad, we were spanked. The police were never called, no matter how loud we hollered. When we were punished, WE WERE PUNISHED!

We would go to the local theatre on Saturday and eat nothing but sugary stuff while we watched a movie that was continued to next week. Thus the cycle began of movies and candy every Saturday.

Those were the days of plenty of exercise and fun without technology – and we survived!

## Facebook and the lack of Social in its Media

Facebook, the seemingly ever present "social media networking service," has hit a rough patch. It is being abandoned in droves or avoided all together by the underthirty crowd, that demographic beloved by advertisers. European Union regulators are hypercritical of the company's business practices, especially concerning privacy. The news media has linked Russian "trolls" bent on sowing discourse in the United States to false "news feeds" posted on Facebook. Most recently Facebook has been accused of allowing data mining by Cambridge Analytica and the possible breaching of private information of Facebook users. So far 2018 has not been kind to Facebook as a number of stock analysts have put a "sell" recommendation on its stock.

In all the analysis of Facebook's current woes the issue of what is a "social media networking service" does not come up. The rise of social media has been driven by technology. We text and message on our phones rarely speaking to each other anymore. Social media was to be the new way we communicate. But does a social media networking service like Facebook really facilitate communication between individuals? As an experiment I chose to look at the first twenty-four posts on my feed and analyze them for content. Specifically were they communication from my 227 "Facebook friends" and what type of communication was it? I divided the content into "original" (created by a "Facebook" friend for their friends to see) or "shared." I further divided "shared" content into advertising, political, inspirational, news, and

So what did I find? Sixteen entities had material posted on my

"wall" for a total of twenty-four posts. Four posts were ads (17%), two were "sponsored" and two were "liked" by friends (or so Facebook claims). Seven posts (29%) were reposted political commentary or memes bashing either the right or left (whether any were of Russian origin created by "trolls" is unknown). A couple of the political memes were amusing but devoid of serious content. Only three postings were inspirational quotes or memes (12.5%). Two postings (8%) were reposted funny YouTube videos: one of the drunken antic variety, the other in the Three Stooges vein of "physical" humor. (Both were posted by male friends upholding the long-held view that Three Stooges humor tends to appeal to the male of the species.) Two were re-postings of news stories (8%). Only six postings were of original content by the poster (25%). So only a quarter of the posts were of content created by the poster to communicate with their "Facebook friends." Of there six original posts five were created by a "Facebook friend" promoting their own business as a photographer. Only one of the original posts could be considered "social" as the other five had a commercial intent as postings to promote a small free-lance business. So out of the first twenty-four posts I examined on my Facebook wall for this article only one was of original content and meant as "social" interaction (4%).

So with all of Facebook's myriad of problems we can add another, Facebook isn't very social. It has become a platform for ads, political and inspirational memes, news stories, and click-bait videos. A social network that isn't used for communicating between individuals is neither social nor truly allowing its users to network and may likely be doomed in the end as users gravitate to newer sites that fulfill both needs. This is possibly the grimmest news facing Facebook this year.

# AAA Speaks Out: Move Over Baby

Move Over Baby Boomers, Millennials Embrace Family

#### **Travel**

The latest AAA Travel survey finds a new generation of Americans embracing family travel.

A new survey from AAA finds that almost 90 million Americans plan to take family vacations this year and, for the first time, millennials represent the greatest percentage of those packing up the kids or joining other family members and hitting the road.

Forty-four percent of millennials are planning a family getaway, compared to 39 percent of Gen Xers and 32 percent of baby boomer.

# **Spring into Action Hello Spring!**

Time to let go of the winter blues and enjoy the crocuses peeking out to delight us with their colors and promise of warmer days and nights.

What's on your mind as you transition from winter to spring? Are you looking forward to new ways to have fun, more energy and to focus on what matters most to you? Perhaps you are slightly concerned about how you are going to show up now that you are shedding all those winter layers of clothes.

The good news is that spring provides a seasonal "fresh start". Nature is amazing. The foods that spout up this season help you to counteract the heavy comfort foods of winter and add essential nutrients to your diet. Here are a few tips to help you put some spring into your step, feel lighter and have more energy.

1. Get some Vitamin D. Vitamin D is commonly known as the sunshine vitamin. According to WebMD, "Research suggests that vitamin D could play a role in the prevention and treatment of a number of conditions, such as diabetes, hypertension, glucose intolerance and multiple sclerosis. It can also lessen the symptoms of mild depression."

Get your best Vitamin D outside in the sun. Many people can also benefit from a Vitamin D supplement. Check with your physician who can get your levels tested during your yearly blood test.

- 2. Walk Outdoors. Why not multitask and walk while you are soaking up the sun. Walking and sunshine are sure ways to boost your energy levels and elevate your mood.
- 3. Join a local CSA- Community Supported Agriculture. CSA's provide you an opportunity to know exactly where your food is coming from and how it was grown. You will have access to the fresh, high quality, usually organic produce for your family. Take your kids and help them to appreciate what it takes to grow a garden and raise fresh food. community and good for you!

- 4. Increase your consumption of seasonal foods. Enjoy asparagus, fava beans, Swiss chard, spinach, mushrooms, parsley, radishes and herbs nettle and thyme. Fiddlehead's pretty spirals also pop up this time a year. To me, they remind me of a musical score and when I walk by a grouping, I almost expect them to break into song. Fiddleheads are high in vitamins A and C, omega 3 essential fatty acids and fiber. Sautee fiddleheads in ghee (clarified butter) or olive oil with onions and garlic and serve over brown rice or quinoa.
- 5. Spring Clean. Your home has been tightly sealed all winter and you are likely breathing in toxic air. Time to open the windows and let some fresh air in. Try adding some detoxing plants to your home, such as Aloe Vera, Spider Plants, Snake Plants and Pathos to help clean the indoor air.

It's also a good time to spring clean your thoughts. If the lack of sunshine has influenced negative thinking, it's time to reintroduce positivity and gratitude. Instead of saying, "I feel fat", how about "I am helping my body and mind feel lighter by introducing exercise and healthier foods to my routine".

Optional: 1 Tablespoon chia seeds
Put all in high -powered blender and
give it a whirl for about a minute.
This drink may not provide the
sweetness you normally crave, but it is
a great way to re-train your taste buds
to love nutrient dense foods.

For years I and most other IT professionals have preached the importance of having and maintaining some sort of antivirus software package installed to protect your computer. Times have changed.

It is still important to have some sort of protection installed on your computer. However, Apple and Microsoft have made great strides in protecting computers from the type of malicious software that we have feared over the years. Windows 10 now includes Windows Defender Security Center which provides very good protection. Apple has always been a more secure operating system. MacOS has plenty of built in protection to keep you safe. With this protection in place, as well as a muchimproved emphasis on security, it is much more difficult for the bad guys to cause trouble on their own.

The weakest link in today's environment is the user. The bad guys typically cannot do bad things to your computer without your permission. They do so by tricking you into giving them permission usually by clicking on something. They do this by sending fake emails posing as your bank, a credit card company, the IRS, or a friend. They do this by putting fake pop ups on your computer that look exactly like anti-virus or malware protection telling you that you must call Microsoft Support or Apple support to fix the

The most important thing you can do to protect yourself is change your behavior. You MUST look at everything with a cautious eye. Nothing on the internet can be trusted completely. Whether it be a post on social media, ANY email, search results from questionable websites, ads and messages that make questionable claims. Do not fall for fake emails. Your bank won't email you and ask for your account information. They already have it. The IRS won't email you to collect their taxes. They send letters.

Rather than waste your computer's resources on bloated protection from companies like Norton, Symantec, and McAfee. Your time and money would be better spent making sure your computer is up to date. Make sure Windows 10 updates are installed regularly. They typically push out security updates once a month, and major feature updates twice a year. If your computer is running Windows XP, stop using it now. It's time to replace it. If you are running Windows 7, make sure you have some sort of Antivirus installed. Microsoft offers Security Essentials for free on Windows 10. Windows 8/8.1 Runs Windows Defender. For Apple computers, make sure that you are running the latest version of MacOS an any updates they

If you really want to make sure your computer is safe, several anti-virus companies offer free online scans. Trend Micro's HouseCall Free Online Scan (https://goo.gl/TAhheA) can be a second opinion to make sure you are safe. Another good one is the Free Virus Scan from ESET (https://goo.gl/ y5c4Pu). Just choose the free one-time

## Senator Martin Calls Commission's Report a Sobering Look at Connecticut's Reality

Hartford – State Senator Henri Martin (R-31) called today's presentation by the Connecticut Commission on Fiscal Stability and Economic Growth a frank assessment of the state's fiscal crisis.

Legislation passed during the 2017 session of the General Assembly established the commission comprised of representatives from the business, education and civic communities. The commission's report was presented to members of the legislature in the House Chambers.

"The information presented today was insightful, acute, and very sobering," Sen. Martin said. "The commission gave the legislature what I believe is an accurate picture of where the state is today and it proposed a comprehensive plan that it believes contains the necessary steps to reverse Connecticut's downward fiscal trajectory."

Sen. Martin said the commission was asked to "Develop and recommend

policies to achieve state government fiscal stability and promote economic growth and competitiveness within the state."

"I believe the commission made a straight-forward effort to study the state's fiscal problems and provide solutions," he said. "Legislators have been given a lot of information to digest. As per the commission's report, Connecticut's fiscal 'burning platform' must be addressed. What is perfectly clear is that bold actions are required. Time is of the essence. We need to review and assess all of the commission's proposals and initiatives to determine the path forward that will provide the state with economic stability and consistent, balanced budgets."

Sen. Martin said he appreciated the time and effort committee members put forward, as volunteers, in assembling the report.

Sen. Martin is a member of the legislature's Finance, Revenue & Bonding Committee and represents the communities of Bristol, Harwinton, Plainville, Plymouth, and Thomaston.

## Dog Park Vote 4-3



The Dog Park location at Norton Park Extenstion failed by one vote.

Five votes were needed, but the vote wound up 4-3 in favor of the project, thus failing to pass.

Scott Saunders voted with the Democrats, Rosemary Morante and Chris Wazorko against it. Voting in favor were Kathy Pugliese, Jesse Gnazzo, Ty Cox and Deb Tompkins.

The Dog Park Committee, headed by Dan Ciesielski and Scott Adamson, recommended last fall that the council approve the location. It is located in the Flood Zone. The one-acre park would be volunteer-funded and volunteer-maintained. The committee submitted a petition signed by over 600 Plainville citizens in favor of the location. The signatures on the petition were secured at the committee's booth at the Firemen's Balloon Fest and the Downtown Pumpkinfest.

"All of the councilors thanked the Dog Park Committee for the time and work they have put in over the past two years," said Town Manager Robert E. Lee. "From here, the issue will be further discussed at the sub-committee level along with me and the Dog Park Committee members. However, I don't see this taking place until after the budget sessions are over in late April

or early May. Whether or not there is a space available for a dog park in town has yet to be seen."

Lee said that councilors who opposed the dog park did so primarily because of the one home located 166 feet away. Rosemary Morante said "It could be considered a kind of hidden-away area. I did my own research on the pros and cons of a dog park and I felt that in an area like that it could be more difficult to monitor and some of the problems could be more likely to occur."

Town Council Chairwoman Kathy Pugliese, who voted in favor of the dog park. said that she knows Morante had reservations about having a dog park at all, she feels the rest of the council is in favor of there being one somewhere in town impinged on their property," she said, But, others were not in favor of doing it at that location. I still believe that we will be able to come up with a location that works eventually. We will still be working with the dog park committee."

Lee noted that during Monday's meeting, councilors declined to comment on the environmental impact study conducted on Tilcon's proposal to relocate its quarry operations to land belonging to the New Britain Water Department. He said the council is waiting to see what happens to the proposal at the state level first.

A public hearing has been set for the proposed town budget, which is being refined at a series of workshops.

Those who wish to comment can do so at the April 2nd Town Council meeting, which will be held at 7 p.m. at the Municipal Center.



THE CENTURY! IN THIS CORNER WE HAVE ANGELINA JOLIE, OSCAR WINNING ACTRESS AND ORIGINAL FILM INCARNATION OF THE VIDEO GAME ACTION STAR, LARA CROFT! ACROSS FROM HER IS THE CHALLENGER, VIKANDER, **OSCAR** ALICIA NOMINATED **ACTRESS AND** FEISTY UPSTART NOW ASSUMING THE ROLE OF THAT VERY SAME VIDEO GAME ACTION STAR, LARA CROFT! LET'S HAVE OUR TWO ACCOMPLISHED THESPIANS COME TO CENTER RING, BUMP GLOVES AND GET DOWN TO IT! ARE YOU READY TO RUMBLE?

I'm not a gamer. Never had any interest. But I love movies. So, without any insight into the video games that inspire the Lara Croft franchise, I approach these films purely from a cinematic point of view. I have been told that the character in the video game had a metamorphism a few years back and that these two talented actresses are not really playing the same role. When Jolie interpreted the role in two Lara Croft films, the character was highly sexualized and was more Sheena, Queen of the Jungle than Prime Suspect's Jane Tennison. Vikander takes on the role after the video game had desexualized the character and eliminated the overt sexual attraction that young game boys would salivate over. Croft is now an action star that relies on her wit, tenacity, smarts and physical prowess to tackle the challenges she faces. Score one for woman power.

Jolie handled the role just fine encompassing the audacity, strength and sexual allure inherent in the video game's heroine. Her films were over the top much like the game and pleasantly entertaining.

Vikander gets to play a more grounded Croft. She still proves herself more than equipped to deal with the challenges she faces but without the self assured posture. This is a Croft

that is discovering her skills. She is experiencing what you could call on the job training. She is not aware of what to do to surmount the physical challenges but makes her choices and improvises as she is faced with these life or death moments. She is learning what her skills are. Vikander is an intensely involved actress that digs deep into the heart and soul of her characters as she does with Croft with surprisingly illuminating results. She gives the character a depth of honest emotions and personality that I can believe. Croft has become a multidimensional human being beyond what I am assuming the inventors of her video game and the gamers that embraced it could ever have imagined. And Vikander gives her all to this incarnation of Croft which humanizes her, making her real and relatable.

Not to be redundant but the best way to describe "Tomb Raider" is to say it is more grounded than the previous films and the game itself. The action and events are all grounded in reality simulating events one can believe actually could happen. It never veers over the top or becomes the least bit cartoonish. Yes, Croft probably would have been killed ten times over if caught in the life and death challenges she encounters but director Roar Uthaug (yes, that's his name!) stages them in a manner which gives the appearance that it would be possible for her to cheat death. Even though the script by Geneva Robertson-Dworet and Alistair Siddons taken from a story written by Robertson-Dworet and Evan Daugherty use events from the recent game, they give it a three dimensional interpretation things from getting overblown, predictable and outrageous. The story might be a bit too pedestrian and rote which lets down all the quality and talent layered onto it but it didn't extinguish my enjoyment of the film. Walton Goggins could be the very best go to actor to cast as a vile villian working in films today. Here he plays



Mathias Vogel, a shrewd nemesis Croft encounters on the island that was her father's known destination when he disappeared. Goggins injects all the slippery charm and dogged determination he used in his best work as Boyd Crowder in the excellent television series "Justified". The calm demeanor and cold blooded aura is Goggins trademark and he plays it for all it's worth.

Dominic West as Lara's missing father gives the proper level of pathos to the role while Daniel Wu as Lu Ren, who joins Lara in her quest, makes his underwritten character a colorful and likable sort you wouldn't mind seeing pop up again should there be further adventures of Lara Croft to come.

Kristen Scott Thomas and Derek Jacobi lend their considerable talents to smaller roles rounding out a well chosen cast.

The film is filled with amazing set pieces from the opening bicycle chase in which Lara is the fox being chased by her fellow bicycle couriers in a challenge game that could earn her much needed cash to her breathtaking fight for survival in a decrepit abandoned airplane about to plunge over the dangerous waterfall, they are all thrillingly staged.

Despite a mediocre plot, Tomb Raider is a well constructed action adventure film that entertains quite satisfactorily and provides a first class experience for all the lovers of a well executed Saturday matinee popcorn flick.





## Prevent Medication Poisonings in Your Home

Most parents know to keep chemicals and cleaning supplies away from children. Many poisonings also happen with medicines. Some products (e.g., gummy vitamins, marijuana edibles, etc) can trick a child into thinking they are food or candy.

For a child, taking even a small amount of the wrong medicine can be deadly. Poisonings in kids due to PRESCRIPTION drugs is on the rise. The good news is that poisonings due to cough and cold meds are down... due to the withdrawal of OTC infant products and age restrictions on children's products.

But adults are using more Rx meds... leading to more poisonings and deaths in kids. Over two-thirds of deaths in children under 5 years are due to med poisonings.

The biggest Rx offenders are sedatives/hypnotics/antipsychotics (benzodiazepines, etc)...cardiovascular drugs (calcium channel blockers, etc)...and analgesics (acetaminophen, opioids, etc).

Some can be deadly with just one dose. Ingesting verapamil 240 mg, glipizide 5 mg, or methadone 20 mg is enough to kill a toddler.

Child-resistant containers aren't enough.

Give parents these tips to keep young children safe.

#### **Safe Use of Medicines**

- Read all the directions on the medicine bottle. Follow them carefully.
- Turn on the lights. Get your glasses.
  Be sure you have the right amount of the right medicine.

- Keep medicines in the child-resistant containers they come in.
- Never share or sell your prescription drugs.

Keeping Children Safe

#### DO No keen the noise

- DO keep the poison center's phone number beside all your telephones and in your cell phones call the Poison Help line ASAP... 800-222-1222. Advise patients to program the number into phones.
- DO keep medicines and chemicals in a locked or safe place where children cannot see or reach. This includes medicines you apply to your skin (e.g., nitroglycerin cream, menthol rubs, etc), natural supplements, vitamins, etc.
- DO put medicines away right after taking them. Child-resistant containers might slow children down, but they can still be opened.
- DO safely dispose of any ipecac syrup you may have. It should no longer be used for poisonings.

#### **DON'Ts**

- DON'T take medicine with children watching. They like to copy adults.
- DON'T call medicine candy or say that it tastes like candy.
- DON'T let guests leave medicines where children can find them, like a purse, coat pocket, or unlocked suitcase.
- DON'T put chemicals or cleaners in bottles or cups. These can be confused for drinks.
- DON'T put your next dose of medicine on the counter or anywhere children can reach it.
- DON'T leave children alone with medicines. It only takes a second for a child to get it.
- DON'T throw away medicine patches, e-cigarette containers, or other medicines where children can find them. Fold used medicine patches with the sticky sides together. Even used patches can contain enough medicine to hurt a child if chewed or stuck to their skin.
- DON'T keep medicines you no longer need. Ask your pharmacist for the best way to get rid of them.

What to Do if a Poisoning Happens Stay calm.

Don't give the person anything to treat the poisoning or make them throw up. Call 911 if the person has passed out, is not breathing, has a hard time breathing, or has a seizure.

If the person is awake, call your poison center.

Stay on the phone and do what the emergency operator or poison center tells you.

#### Proper disposal

Parents are advised to get rid of unwanted or expired meds by dropping them off at take-back programs... placing them in the trash...or flushing certain controlled substances.

DEA's next Rx drug take-back day is April 26.

There are only two kinds of religions in this world:

(1) a religion based on a works-based salvation, and (2) a religion based on a faith-based salvation. Which does the Bible teach? Let's us take a quick look at the words of Jesus Christ Himself. John 3:16, "For God so loved the world, that He gave His only begotten Son, that whosoever believeth in Him should not perish, but have everlasting life." Jesus paid the price for sin on the cross therefore He is able to offer salvation as a free gift to whosoever will believe and receive Him as Savior. *Have you done that? It is the only way to be saved. Do it today for time is running out.*

## TASTE BUZZ.....

Wild Rice & Oyster Casserole

1/2 cup butter

3/4 cup minced onion

3/4 cup celery

3 cups cooked wild rice

1 pint oysters with liquor

Milk

1 teaspoon salt

1 cup grated Swiss cheese

Heat 1/4 cup of butter in a skillet and cook the onions and celery until soft and barely golden. Combine with the wild rice. Grease a 1-1/2 or 2 quart casserole and arrange alternate layers of rice and drained oysters in it, ending with a layer of rice. Reserve oyster liquor and add enough milk to it to make 3/4 cup liquid. Add salt to the milk and oyster liquor and pour it over mixture in casserole. Top with grated cheese. 






We had Aunt Jemima flown into Robertson Airfield, a motorcade of convertibles through town and to the High School. Guests took pictures of their children with the real Aunt Jemima as she visited with the guests. (If you have a picture of your child and Aunt Jemima, please let us know, of course, they will be over 60 years)

"IT WAS A HUGE SUCCESS"

The Lion members helped us for the next 3 years, and the club reached their goal, hired Mrs. Herb Segal, starting the Dental program with three years salary. Now, Mr. Loomis said it was about time the Lion's club should reap some funds for their treasury. WELL, you guessed it "THE TORCH WAS

HANDED TO THE PLAINVILLE LIONS CLUB. Then the Board of Education continued with the program once it was established.

The Lions have done themselves proud. It is some 60 years later and the Lions still ROAR with their success, may you keep it up another 60 years. The citizens of Plainville look forward every year to attend the Lion's Breakfast.

PRIVATE STUDENT LOANS

Student loans... and more to the point, student loan debt, is a problem this country is being faced with at a historical rate. The government is the lender for most of the student loans issued in the U.S., yet there has still been a rise in the private student loan sector. These private student loans are treated differently and you should have an understanding of them before signing on the dotted line.

First, private student loans are not backed by the government. Prior to 2005, banks would get these private loans federally guaranteed. The government got wise to how much the banks were making and decided to get into the business for themselves. So after 2005, they cut out the middleman and started solely issuing loans. So now when banks offer private student loans they attach extra controls like requiring a co-signer.

Most importantly, the 2005 reforms directly affected how student loans were dealt with in bankruptcy. Prior to 2005, private label student loans were treated like other unsecured debt in bankruptcy, and were essentially discharged at the end of the bankruptcy case. Now they enjoy the same status and protection of federal student loans in bankruptcy. They cannot be discharged in a chapter 7 bankruptcy with a very limited exception. So, if you can't discharge your student loans, the alternative may be to get temporarily relief by paying a reduced amount through Chapter 13 bankruptcy. But keep in mind that you'll still be on the hook for whatever amount is left after your repayment period ends.

So what is the exception

for getting my private student loan discharged in bankruptcy? The most common exception for bankruptcy courts is the Undue Hardship Standard. In order to meet this standard in bankruptcy court the petitioner needs to file a complaint in addition to their bankruptcy petition. This complaint needs to lay out how the petitioner meets the three part undue hardship standard. The first part requires the petitioner to describe how they are subject to a minimal standard of living if forced to repay their loans. A minimal standard of living is not a middle class standard, but a much lower standard of living. The courts expect you to maximize your income and minimize your expenses. The second prong calls for your current financial situation to likely continue for a significant part of the repayment period. The last part is that you are and have made a good faith effort to repay your student loans.

The difficulty in making the undue hardship argument is that you can almost guarantee that the bank is going to object. This ensures that the petitioner is going to have to employ a knowledgeable attorney to research and fight this battle. This is an expense that most petitioners in this situation cannot afford. Also it begs the argument from the bank that if you can afford to pay attorney than you can afford to repay your loans.

Private student loans also typically have higher interest rates than government issued loans. So be careful when agreeing to the terms of these student loans as they enjoy the bankruptcy protection of government loans, but without the regulatory safeguards of the federal loans.


