Robert E. Lee, Town Manager's Report to Town Council November 15th

Town Council Report Red Cross Team

- During the early morning hours of November 3rd, a fire occurred at the Russel Gate Condominiums located on Russell Ave. As a result, Five Families (9 Adults/2Children) were displaced.
- The Red Cross immediately sent in a "Integrated Care & Condolence Team" to assist the displaced residents. Funds were provided for their immediate needs including comfort kits and Recovery Envelopes.
- As a result of the fire, three of the units will need extensive repair before they can be re-occupied.
- I want to thank the Red Cross for assisting our residents in their time of need. They are always there when we need them most.

Tomlinson Avenue Bridge Project Discussion

- The replacement of the Tomlinson Ave. Bridge is finally ready to move forward. Over 10 years ago the Town secured a federal grant to pay for 80% of the cost of the replacement. Due to many factors including bridge re-design and additional analysis required by the Corps of Engineers the project was delayed.
- On October 21st, nine bid proposals were received for the project which involves the installation of a twin pre-cast concrete box culvert.
- The low bid was submitted by Dayton Construction of Watertown in the amount of \$1,296,849.50. The engineer's estimate for the project was Town \$1.4M. and State consultants have reviewed the submitted bid documents and have found them to be complete. Dayton Construction successfully completed the replacement of the Stillwell Drive Bridge several years ago.

Town staff is recommending that the Town Council award the replacement of the Tomlinson Ave. Bridge Project to Dayton Construction of Watertown in the amount of \$1,296,849.50. There is an item under New Business regarding this recommendation.

Town Aid Road account. **CT** Communities Challenge Grant Program

- Governor Lamont recently announced new economic development programs to create and boost community jobs vibrancy. One of the programs is the "Connecticut Communities Challenge Program". Under the Connecticut Communities Challenge program, the Department of Economic and Community Development will fund a wide range of projects that improve livability, vibrancy, and appeal of communities throughout the state while aiming to create approximately 3,000 new jobs.
- Town staff is planning to submit a grant application which, if awarded, would provide funds to assist in the infrastructure improvements which are part of the White Oak Development Project. There is a match required for the grant. Manafort Newport Realty has agreed to provide a good portion of the required match.
- It is anticipated that the grant request and the match will total around \$1.6M. Town staff will work with Manafort Newport to submit an "Intent to Apply" by December 3rd and the completed application by January 14th. It is expected that the State will not announce the grant awards until next Spring.

BAN Sale Results

- The Town recently received bids for General Obligation Bond Anticipation Notes totaling \$7M for the period from November 17th until August 16, 2022. Three bids were received with the low bid submitted by BNY Mellon with a net interest calculation of 0.4081%.
- It is now anticipated that the Town will issue a General Obligation Bond when these notes become due next summer. These notes and bonds are for the Wheeler Elementary School Project and the Road Bond Program.

FY2021 Audit Governance _ Communication

CliftonLarsonAllen LLP of West Hartford is currently conducting the Town audit for the Fiscal

management. A copy of the letter was included in the information package for this evening's meeting. No action is required by the Town Council at this time.

The Town audit is currently underway and is expected to be completed by the end of December.

Honor Heights Proposed Sewer Survey

- Town staff recently solicited ٠ feedback from those residents that attended the September 16th Public Information Session held to discuss the possible installation of sewers in the Honor Heights neighborhood. The neighborhood has 82 homes.
- Forty persons representing 32 homes attended the meeting. The survey results were that 69% (22 homes) of those who attended the meeting were in favor of the Town to continue considering whether to move forward with the installation of sewers.
- Three residents indicated that they made some repairs to their septic system in the recent past and saw no need to have the sewers installed. One person stated "maybe", and another wanted to remain "neutral". Five persons did not respond to the survey.
- Based on the feedback, Town staff is recommending that some preliminary cost estimates be determined, and a potential financing plan be developed for review by the Town Council.

Farmington Avenue Tree **Replacement Discussion**

- Last summer the State D.O.T. removed approximately 10 trees on the west side of Farmington Ave, (Route 10) because they were dying and showing signs of stress. Approximately 20 years ago the Town planted some of these trees that were removed.
- ٠ The section of trees removed stretched from West cemetery to Roberts Street. Several residents have inquired as to whether the Town will be replacing these trees in the future.
- Town staff has provided a potential location for the replacement tree plantings. The estimated cost of the replacement is around \$10K. This could be reduced if the Town crew were able to perform the plantings. If the Town Council wishes to consider the replacement of these trees, Town staff will put together a more definitive cost and a recommended funding option. **Hemingway Street Drainage**

- Town staff is soliciting feedback from the Town Council whether Town staff should put together more definitive information regarding this drainage problem.
- **Eversource Gas Replacement 2022**
- Town staff recently met with Eversource Gas representatives regarding their plans for replacing some older gas lines in Plainville. Eversource is planning to replace gas lines on Canal Street, Strong Court, Church Street and Bank Street this winter. They are also planning to replace gas lines on Tomlinson Ave. west of Route 10 and on Park Street from Tomlinson to Broad Street.
- Town staff and Eversource have agreed that any gas line replacements on streets that were repaved within the last five years would be overlayed with the cost being paid by the gas company. We also agreed to share in the cost for pavement overlay on those streets where the road is in relatively good condition to extend the life of the road.
- Work is expected to begin in these two areas towards the end of January. Eversource will be required to maintain the roads during construction as directed by Town staff.

COVID-19 Update

- Plainville continues to be in the "red" category with an average daily rate of 15.1 cases per 100K. This is just above the 14.9 cases per 100K which would put Plainville in the "orange" category. This could be partially due to the lower-than-average vaccination rate by Plainville residents.
- According to the "CTPUBLIC. website, 64.9% ORG of Plainville residents have been fully vaccinated. The state "fully vaccinated" rate is 81.8%. The U.S. "fully vaccinated" rate is 68.6%.
- By contrast Farmington (yellow) rate stands at 77.6%, Southington (orange) rate is at 70.1%. Another factor could be that Plainville has a much denser population than most municipalities in Connecticut.
 - The latest positivity rate for COVID-19 in Connecticut is

- In addition, the State is requiring that the Town Council authorize the Town Manager to execute a "Project Authorization Letter" for the project. There is an item under New Business regarding this requirement as well.
- Finally, the estimated remaining cost for the project is \$1.54M. The Town share of 20% is calculates to \$308,156. The current balance left in the Tomlinson Ave. Bridge Fund is \$157K. The remaining amount of \$151,158 will be paid from the

Year Ending June 2021. They issued a letter dated October 29, 2021, communicating information relating to the audit.

The letter detailed the responsibilities of both the auditors as well as the Town. The letter also speaks to the "Planned scope and timing of the audit" and "Other planning matters" related to communication between CLA and Town staff.

- The letter is intended solely for the information purposes for use by the Town Council and Town
- For several years some residents on the west side of Hemingway Street have expressed concerns regarding drainage issues impacting their property. This drainage issue is related to surface and groundwater flowing southerly toward remnants of the Farmington Canal located

2.42%. This is a slight increase from previous weeks due, most likely, from Halloween and more indoor activities. This was expected and, hopefully, will not increase much more than that going forward.

Sewer Billing was mailed at the end of October and due November 1, 2021. December 1,2021 is the last day to pay without interest.

*Municipal Broadband **Interest Survey**

The Town of Plainville has launched an online broadband interest survey for residents and business owners. The purpose of the poll is to gauge public support for building a municipally-owned fiber-to-the-home (FTTX) broadband network that would offer connections to all town residents and businesses. Plainville property owners can access the survey and learn more at plainvillect.com/broadband or by going to the Resource Center on the town website and clicking the Broadband Interest Survey button. The survey will be live until June 1, 2022.

Plainville is currently working to deploy a municipal fiber network connecting town offices, wastewater facilities, treatment emergency services, and educational institutions in all four corners of the town with the town center. This state-of-theart fiber infrastructure, including 12.5 miles of aerial cabling and three underground spans running beneath major highways. Installation of the municipal network opens the door for Plainville to efficiently build out a town-owned FTTX network.

Town Manager Robert E. Lee Retires Serving Plainville for 17 Years

Town Manager Robert E. Lee said he plans to retire in January after serving the town since 2004, seeking to spend more time with friends and family in Flordia.

"I had a great run, but at this stage of my life, it's time for me and my wife to be doing something different and for me that means retirement," Lee said. "I enjoyed coming to work each and every day. I will miss Plainville - the town and the staff. We have a great group of people working here. I have mixed emotions about retiring. If the (town) council ever needs my assistance I am still beyond willing to help if it is requested."

Although Lee will be moving to Florida, he said he plans to come up to visit in the summer.

"I guess I'll be becoming a snow-bird." he joked. Lee's last day as town manager will be January 5th. He is the longest serving of Plainville's managers and has served for 42 years in local goverment.

Prior to becoming Plainville's town manager, he was Hebron's town manager from 1990 to 2004. Prior to that, he was assistant town manager in East Hampton from 1978 to 1990.

"Working in local government you can make a positive difference and you can see the process through from beginning to end" he said. "I worked with many council members over the years, without exception, to do what was best interests of the community. That and our ability to attract good staff in Plainville is what kept me in Plainville is what kept me in town as long as I was here. I also feel like we changed the culture of the way that we responded to citizens' concerns. We became more responsive and focused on solving problems."

During his time in Plainville, Lee is proud to have helped to secure the purchase of Robertson Airport in 2009. He also cited as an accomplishment the consolidation of the town and school district's finances and HR departments, which he says enco uraged town and education leaders to work together.

During Lee's time as town manager, renovations and improvements were made to Plainville High School, Wheeler and Toffolon Schools. He also saw the town's Water Pollution Control facility upgrade through to completion and worked with the town council to initiate a road repair bonding program.

Lee said he is also proud to be leaving Plainville on "very solid financial footing."

"We have had very minimal tax increases over the last three years, keeping less than or at the rate of inflation." he said.

During Lee's time as manager, the town upgraded all traffic lights twice which, since 2006, saved the town approximately \$1 million on energy costs.

Lee said the town was also proactive in buying homes and relocating residents from flood plain areas such as Robert Street extension. This he said, prevented what could have been a "disaster" when the area flooded again following Hurricane Ida.

Before, his last day. Lee said he hopes to continue to work to advance the redevelopment of the White Oak property, move forward sith the Farmington Canal Heritage Trail gap closure and move ahead on renovations to the Middle School of Plainville. He also wants to help put a plan into place for how to use American Rescue Plan funding.

I will recommend that the town council create a committee with town staff and council members to determine how best to spend that money," he said.

Lee's wife, Peggy, became the prganizer of the Wings & Wheels Festival after former council member Scott Sanders and his wife, Andrea, who former; y chaired the Board of Education, also moved to Florida in 2018. Lee said he hopes someone will take over and carry on the tradition."

Lee also imparted some words of advice for whoever is hired to succeed him as town manager. "Trust the town staff and engage with the public as much as possible," he said. "Get out, walk around and familiarize yourself with the town. The people that you meet as part of your day will help you understand what people are looking for. By and large, the people were very supportive of myself and town staff and supported us."

Town Council Chair Kathy Pugliese was on the Town Council when Lee was hired. She said his "insight and leadership will be truly missed."

"I recall his answer when asked what he thought

was most important aspects to any community-his response was education and public safety," Pugliese said. "To this day both are critical to any successful community."

She too cited the combination of the Board of Education and Town's financial departments, human resources and technology as a major accomplishment.

"This is a model of synergy many other towns have looked to Plainville as a basis for change in their operational structure, "she said. "Most recently he was in command during the overwhelming issues related to covid-19.

Pugliese said Lee's care for the community and determination for excellence set Plainville apart as a model for other towns in Connecticut.

We are also rated at AA+ by Moody's rating agency as a result of outstanding financial management. she said. "He has created a legacy of innovation and progress for Plainville which sets us apart from many other communities."

Councilor Deb Tompkins said Lee is a "24/7 town manager." She pointed out he was very responsive on social media, frequently answering residents questions on Plainville Talks.

"When people need their questions answered, he's always there to do it," she said. :He has been a very good town manager and is always great with the budget. His retirement will be a loss for us. It will be hard to replace him."

Town councilor David Underwood said Lee was "outstanding" as town manager.

"He will really be missed," Underwood. "It will really be very hard for the council to replace Robert. I wish him all the luck in the world. He deserves it. He worked really hard all the years he has been in Plainville.

Town councilor Rosemary Morante said it has been a pleasure to work with Lee.

Robert's breadth of knowledge, competence, ability to manage many things at once, and his responsiveness to town residents are among the many attributes that have had a positive impact on Plainville," she said. "It will be a challenge to replace Robert."

EDA Update

Willow Brook Estates: Newport Realty Group, part of the Manafort-Newport team that will oversee the redevelopment of the White Oak property, has begun site work on an age-restricted development after receiving town approvals over the summer. The 61-unit development located just off Unionville Avenue in both Plainville and Farmington, will allow residents the option of three different detached ranch style homes ranging between 1,444-1,610 square feet. Standard features include an open floor plan, cathedral ceilings, fireplaced family room, master suite, walk in closets, and granite countertops. Prices start at \$359,900. As of Friday, November 5, 30 of the 61 units were under contract. The high level of interest will push construction ahead of the proposed schedule with both Phase 1 & Phase 2 being done concurrently. Clearing of the property has just begun, and it is anticipated that homes will begin to close in June 2022. I will include some additional items in the hard copy mailing, but if viewing on the computer, you can read more about the development here. Robertson Airport Improvements: The Town and Interstate Aviation are working together to complete a renovation of the current Administrative Building at Robertson Airport. When completed, a new observation area will be open to the public featuring a paved outdoor patio and lawn area with seating, firepit, and new landscaping, and an internal renovation which will feature new office

and conference rooms, seating areas with observation windows, and a café that will serve breakfast and light lunch options. Costs are being split between the two parties with Interstate Aviation fronting costs for internal renovation, and the Town fronting costs for outdoor improvements. Basic site work has recently started, and the project is scheduled to be completed for spring 2022. The additions will highlight one of Plainville's unique offerings and will be a popular place for aviation enthusiasts, and the general public, to visit. I will include schematic plans for the final build out to this mailing.

White Oak Update: At the October 25th Town Council meeting, we received approval to execute the Term Sheet agreement, outlining the general parameters and responsibilities, between the Town and Manafort-Newport. That document was subsequently executed and filed with DECD as part of our Brownfield grant. Attorneys are now beginning to draw up a Property Disposition Agreement which will memorialize the points of the Term Sheet, as well as additional agreements between the parties and finalize development details. The Town also received a proposal from CT Brownfield Land Bank for their eventual role in the administration and management of the Brownfield grant on behalf of the Town. The document is being reviewed by attorneys and should go before the Town Council for approval to execute at their next meeting. Additionally, following a conversation with DECD, the Town is working with CTBLB on the formation of a request for proposal (RFP) to licensed environmental professionals to oversee remediation efforts on the site.

Finally, CT DECD recently announced the launch of two new grant programs, one of which the Town is interested in pursuing through the lens of the White Oak redevelopment. The CT Communities Challenge

Grant's goal is to address downtown and "hub" developments, increase housing, develop "essential infrastructure", and further develop mobility improvements, public space improvements, and access to mass transit. Based on proposed development plans, the remediation and redevelopment on White Oak appears to be a potentially ideal fit for the grant's purpose. At this point, the Town is beginning to work with the Manafort-Newport team to scope out potential project parameters in which the grant funds could be best utilized. An "intent to apply" form must be completed by December 3rd and a full grant application by January 14th. If a decision is made to proceed, I will head the effort and work with other project stakeholders to file the grant application.

Holiday Lighting Tips

The Holidays are such a magical time of year. I already find myself getting eager to adorn my home with red and green festive décor and reminders of joyful Holidays past.

Soon the lights will be strung on my front porch and the tree will be making its way to the living room for the honorary tree lighting night. We will add MORE brightly colored lights to the tree and begin to open all of those ornament boxes and reminisce about the events that prompted these beautiful mementos. As a lighting store owner, the lights are clearly my favorite part. And while lights are synonymous with the Holidays, there are a few tips we can remember to be as SAFE as possible. The Right Kind of Holiday Lights

As I'm sure you probably do, I find my Holiday decorations in a bin that I've stashed away from years past. Before you put them up is the best time to look them over. Your string light cords should be inspected for any brittle areas or knicks. You should also remove and replace any bulbs that have gone dead (not lit). Empty sockets can cause the entire string to overheat. Also, plug the lights in to test them before you go to the trouble of putting them up. Consider

upgrading your string lights to LED versions if they aren't already. It will save you electricity and the LED lights last on average 40 times longer than incandescent ones.

Electrical Outlets

It's important not to overload your electrical outlets (indoor or outdoor) with over-the-top displays. If outdoors, be sure your lights are plugged into a GFCI (Ground Fault Circuit

Interrupter) outlet. This will automatically detect any interruption in currents and cut power to an outlet if an issue occurs. Also, be cautious about how you use extensions cords. Inspect them like the string lights and use outdoor-rated ones for any outside or damp areas.

The Clean Up

While this seems like the worst part of the Holidays, it's best to take your outdoor lights down in a timely manner. Extended exposure to harsh outdoor weather can cause damage and lessen the life of your beautiful lights. Be sure to coil your lights loosely around cardboard while getting them ready to stow away. Any tangles will cause problems untangling next Holiday season.

VOLUNTARY COMMITMENT LAW

There are several variations of a psychiatric hold in Connecticut. This article explores when an individual voluntarily seeks help at a medical facility. While most people want to get help on their own terms there still needs to be parameters for both sides. That being said, let's take a look at how voluntary commitments are governed.

A hospital must notify a hospitalized individual within 24 hours, prior to the time an application for commitment is filed, that they may continue as a voluntary patient. Presented with the choice of being deemed "voluntary" or "involuntary" is important because commitment paperwork can make people very wary about receiving treatment. It triggers that fight or flight mentality in a lot of people who figured they were in control of their treatment. So when choosing a voluntary commitment the chances of a successful stay are increased.

Once a voluntary commitment has been established the hospital can still file commitment paperwork

Community Invited to Celebrate Jewish Festival of Lights

On Sunday, December 5th, the greater Southington/Bristol Jewish community is invited to celebrate the festival of Chanukah with music, food and candle lighting. Gishrei Shalom Jewish Congregation will host the event at a member's home in Bristol beginning at 5:00 p.m. Masks are strongly encouraged as is social distancing.

Rabbi Alana Wasserman, the congregation's spiritual leader, will chant the traditional prayers. Everyone is encouraged to bring their chanukiyot, candleholders which have room for a candle for each night of the holiday, plus a "servant" candle which lights the others. As this will be the last day of the eight-day holiday, the room will be filled with candle-light.

Chanukah is a minor holiday in the Jewish calendar and is called the "Festival of Lights". It commemorates the Jewish victory against the Syrian Army in 160 BCE and the miracle that there was only one night's worth of oil to light the eternal lamp in the Temple in Jerusalem but it burned for eight days. In that time, the Jews were able to obtain more oil.

Potato pancakes and sufiganyot (jelly doughnuts) are traditional parts of the Chanukah meal are a reminder of the miracle of the oil since they are fried. The holiday celebration continues with singing and games including "dreidel". The dreidel is a four-sided top with a Hebrew letter on each side. The Hebrew letters stand for "A Great Miracle Happened There".

Gishrei Shalom Jewish Congregation was established in 1984 and is part of the Reform movement. Services are held in the chapel at the First Congregational Church of Southington. In this month's article, we will be sharing some common winter safety tips to prevent injuries and help keep you safe & healthy this winter. Whether you're shoveling, skating, skiing, snowboarding, or doing any other activity, it's important to take precautions to avoid injury.

Although winter activities can be really fun and a great way to remain active during the cold months, they lead to high rates of injury during the season. Some common injuries include sprains, strains, dislocations, and fractures. It's common for these injuries to occur at the end of the day when people overexert themselves. Many of these injuries are preventable and participants should be sure to prepare their bodies. This can be done by keeping in good physical condition, never participating alone, warming up to avoid cold muscles and tendons sustainable to injury, wearing appropriate protective gear and clothing, and drinking plenty of water before, during, and after any activities.

Common Winter Sports Injuries & Tips to Avoid Them

Knee and Ankle Injuries:

Downhill skiing and snowboarding put you at a substantial risk of injury to your knees and ankles. An ankle sprain can be more painful and take longer to heal than an ankle fracture. The most common ankle injury is an anterior cruciate ligament (ACL) tear. Tears or ruptures of the ACL or Medial Collateral Ligament (MCL) of the knee are some of the most debilitating injuries and often require surgery. To help protect yourself from these injuries, have your board bindings inspected frequently and

be sure that your footwear is sized properly. Hand and Wrist Injuries:

It is very easy to break your wrist or fingers when skiing or skating or with a slip and fall. Proper footwear is essential to avoid slips and falls. The straps of the ski pole could lead to an injury to your wrist or a tear to the ligaments of your thumb. A common injury called "skier's thumb" occurs when you fall awkwardly onto your hands while holding a ski pole. This results in a UCL tear which is a ligament on the inside of the thumb. You can prevent this by making sure your ski straps stay below your wrist.

Lower Back Injuries:

Cold weather constricts muscles and diminishes flexibility. Back pain can occur as a result of failing to warm up properly and overworking your body. A more serious back injury can occur as a result of a fall that causes damage to vertebrae or compresses the discs in your back. To prevent this, keep your back and abdominal muscles strong before you start your winter activities to give you the muscular endurance you need.

Snow Shoveling Injuries

Perhaps surprisingly, shoveling results in a very high number of injuries. This is due to improper form while clearing snow. There are many ways in which you can remain injury free while clearing your sidewalk or driveway.

It is important to warm-up before performing a strenuous physical activity. This is especially important before going out into the cold. This can consist of a five to ten minute warm up which can include walking briskly, running in place, or stretching to increase the blood flow to your muscles and prepare them. These preparations are important because warm muscles are able to adapt to unexpected movements much more quickly than cold muscles. Again, it is important to wear proper footwear with an adequate tread to prevent dangerous slips and falls on icy surfaces this time of year.

Improper form while shoveling leads to injuries and strains of inadequately conditioned muscles between the shoulders, upper back, low back, buttocks and upper legs. Proper form involves squatting with your legs apart, knees bent, and back straight. Always remember to maintain good posture and to consider the natural curve of your spine as you shovel snow. For this reason, you should keep the shovel close to your body and lift with your legs. It's also important to avoid twisting and turning movements while shoveling snow in order to prevent back injuries.

Choosing the proper shovel is also important. An ergonomic snow shovel that weighs less than 3 pounds, can take some of the effort out of snow removal. A shovel with a curved handle or an adjustable handle length will minimize painful bending. An ergonomically correct shovel should be used to push the snow rather than lift it. Ideally, you will keep your hands about 12 inches apart when gripping the shovel to provide greater stability and minimize the chances of injuring your low back. Lastly, it's important to pace yourself, take frequent breaks, and stay hydrated.

10 Hard-to-Believe Insurance Facts Some of these rather astounding things to know can save you money.

The world of insurance is far more interesting than you probably think it is. For example, in Japan, golfers have bought golf insurance because if they ever hit a hole in one, they'd have to spend a lot of money buying drinks and gifts for lots of people. Meanwhile, some people's body parts have been insured, with Kiss bass player Gene Simmons once having his tongue insured for a million dollars.

Here's a look at 10 surprising and interesting facts about insurance, some of which you may want to act on, as they could save you money.

No. 1: *Home insurance policies* usually cover damage from volcanoes and even meteors. Like though, earthquake damage is usually not covered. Talk with your agent, to find out exactly what is and isn't covered,

No. 2: Reducing unnecessary emergency room visits can bring healthcare costs down a lot Many visits to emergencies are not truly emergencies: People going there may instead be treated by their primary physicians or perhaps an urgent-care facility. Emergency rooms are costly: "It is estimated that more than \$18 billion could be saved annually if those patients whose medical problems are considered 'avoidable' or 'non-urgent' were to take advantage of primary or preventive healthcare and not rely on ERs for their medical needs," according to the folks at Debt.org. It was able to reduce emergency room use by several percentage points, equaling about \$4.5 million in cost avoidance. Another important result is that emergency rooms end up less crowded, and those who truly need to be there may be seen more quickly. No. 3: Your credit score can significantly influence your insurance costs You probably know about credit scores that influence the mortgage interest rates you're offered, but you may not realize that there are "credit-based insurance scores" that influence the insurance premiums you're quoted -- and sometimes significantly. "Drivers with poor credit may pay twice as much for car insurance as those with exceptional credit. Nationally, improving your credit score from the Poor to the Exceptional range would save you 53% (more than \$1,400) per year." Fortunately, you can take some steps to increase your credit score.

No. 4: *Home insurance policies often prohibit certain dog breeds* Many home insurance policies often prohibit you from having certain kinds of dogs as pets -- because they can potentially cause problems. Some 4.5 million people are bitten by dogs annually, and about 20% of dog bites require medical attention. Dog breeds commonly excluded from standard policies include Akitas, mastiffs, pit bulls, Alaskan malamutes, and Rottweilers. If need be, you can pay extra to add coverage for your dog, or by shopping around, you might find a policy that covers it.

No. 5: Car insurance for male teenagers can be surprisingly costly College costs aren't all you'll face as your teenagers start driving: You'll also need to have them covered by car insurance, and that can be quite expensive." Sixteen-year-olds have twice as many accidents as 18- and 19-year olds, and adding a 16-year-old to your policy can cost you as much as \$3,000 or \$4,000 or more, respectively, for a girl or boy. (If you need such insurance, shop around, as rates can vary very widely.)

No. 6: Some employers offer healthcare for parents of workers Many Americans get employer-sponsored healthcare -- for themselves, or themselves and their spouses, or themselves, their spouses and their children. That's a given. In China, though, offering to cover the parents of workers. It's limited to workers who have been with the company for at least two years, and it provides critical-illness coverage for some 30 illnesses to parents who are younger than 75 and who live in China. It's not unthinkable that new kinds of insurance will be available to Americans, too. We didn't always have pet insurance, for example.

No. 7: *Many Americans think the Affordable Care Act and Obamacare are different* The launch of the Affordable Care Act, also known as Obamacare, was met with vociferous opposition from many Americans, along with strong support from many others, and many Republicans have been trying to eradicate or weaken it for years, with some success. No. 8: Obamacare is doing more than making healthcare more accessible Another thing that many don't quite appreciate about the Affordable Care Act is that it's triggering big changes in the American healthcare system. With millions more people covered, many of whom are in poor health and needing a lot of care, the industry has been undergoing a shift from a fee-for-service model to a value-based model. The value-based model focuses on outcomes more than services, and can keep people healthier and save money in the process. Doctors and hospitals, for example, can earn more if their patients get healthier, stay healthier, don't get readmitted to hospitals soon after being discharged, and so on. This approach can keep populations healthier while keeping costs down, permitting insurers to charge lower premiums, too.

It's not hyperbole to say that "No Time To Die" is unlike any James Bond film that preceded it. Oh, it has all the requisite action, beautifully staged car chases, terrific shoot outs, thunderous explosions, death defying stunts, exotic locations, maniacal villains seeking world domination, alluring women who can deliver a knockout punch, great gadgets and tongue in cheek humor. However, this time around, the story is jam packed with more personal focus and emotional depth. I was in eighth grade when I ventured into the Palace Theater to see a pot boiler film starring Kirk Douglas called "A Town Without Pity". The co-feature was a film I had never heard of but little did I know it would leave a lifelong

impression on me. The film was "Dr. No" and it turned me into a James Bond addict, reading all of Ian Fleming's novels, impatiently waiting for each new screen adaptation, buying all the soundtrack albums and even making an amateur film that was a take off on Bond. All the Bond films haven't been winners for sure but they all had some entertainment value. Sean Connery became the quintessential Bond but when he left, the franchise continued without him. Four other actors took on the mantle of Bond with different levels of success. However, a true successor to Connery didn't emerge until Daniel Craig blazed the screen in Casino Royale. One could immediately recognize the fact that he came the closest to interpreting Fleming's Bond since Connery.

To my original point, there hasn't been a Bond film quite like this one. It has a clearly delineated plot revolving around a chemical weapon that utilizes human DNA to seek out and kill its victims. Of course, It has fallen into the wrong hands. Bond is now retired from MI-6 and living a peaceful life with his wife, Madeleine (Léa Seydoux). An attempt on Bond's life throws suspicion on Madeleine. A high octane chase that rivals anything we've experienced in the Bond franchise ends with him putting Madeleine on a train believing she has betrayed him. Five years later, living a quiet life of solitude, he is approached by his old friend from the CIA, Felix Leiter (Jeffrey Wright). Leiter asks for help in locating a kidnapped scientist. A run in with some SPECTRE thugs convinces Bond to help his old friend out.

Unlike the Bond films that came before Daniel Craig which were basically standalone stories, all his entries in the franchise have contained ongoing plot threads. This being his last outing as Bond, these plot threads are all addressed and brought to resolution. The most rewarding of these is the romance between Bond and Madeleine who had walked off into the sunset at the conclusion of "SPECTRE". Craig and Seydoux have electrified chemistry together and never let us forget that this is a couple consumed with love for one another.

Familiar faces abound as regular cast members Ralph Fiennes as M, Ben Whishaw as Q and Naomie Harris as Moneypenny all make welcome returns. Even Christoph Waltz returns as master criminal Blofeld. New faces impress as well. Lashana Lynch as Nomi, the newly designated 007 is a good fit. The film's undisputed scene stealer is Ana de Armas (Knives Out) as Paloma, a newly trained CIA agent who stands





toe to toe with Craig in taking on a barrage of thugs in one of the film's best action scenes.

Oscar-winning cinematographer Linus Sandgren (La La Land) works with director Cary Joji Fukunaga to not only capture the beauty of the exotic locations but also to provide clarity and realism to the mind boggling action sequences.

Hans Zimmer's pulsating score nicely intertwines the original Monty Norman James Bond theme and the Billie Eilish title song.

Of course the crowning achievement here is the thoroughly engaging performance by Daniel Craig as Bond, James Bond. He has the swagger down as well as the sophistication and the cold stare. He effectively gives Bond a vulnerability the character lacked in past interpretations. His expressive eyes tell of the depth of feelings we don't usually associate with Bond. Craig can wear the vulnerability without sacrificing the hard ass persona we associate with the character.

For lifelong Bond fans such as myself the film's conclusion will catch you off guard. My reaction aside, it can't be denied that this is a fitting tribute to the character and an inspired culmination of Craig's tenure as Bond.

Plainville looking to Galazyn to keep confidence up, team going in Class M tournament

Blue Devils to face Woodland Wednesday night in Class M's second

PLAINVILLE – It's been a season of firsts for Plainville girls volleyball this year.

The Blue Devils qualified for their first state tournament appearance since 2016, secondyear coach Alle Caponigro accumulated her first winning season at the helm with a 15-5 regular-season record and on Monday, Plainville picked up its first playoff victory in five years after sweeping Abbott Tech.

The Blue Devils' sudden success has forced them to learn on the fly and while there have been bumps along the way, the positives continue to outweigh the negatives as Plainville makes a push in the Class M state tournament.

"As many seniors as we have out there, they've never experienced this type of energy, they've never experienced this type of tournament-style play," Caponigro said. We told them before this tournament started that this is either going to push you or it's going to dwindle you down a little bit and I think they're using it in the right way During the CCC tournament last week, the Blue Devils suffered a humbling defeat to the eventual tournament champions Bristol Eastern in the first round. Confidence was down after the 3-0 loss but Monday's win over the Wolverines reaffirmed Plainville's belief in itself.

"It's tough to go into a conference tournament against the one team that's beaten you year after year after year," Caponigro said. "That's a tough mental thing to overcome. As disappointed as we were, we knew that Bristol Eastern was going to go far in that tournament. It would've stunk if the team we played against lost in the next round. That would've stunk, but they went and won the whole thing. Kudos to them, they're a fantastic program, but I think my girls came in here this past week practicing, scrimmaging and knowing that they had what it took and they deserved to be in this tournament. I think that confidence and building it up in them and continually telling them, you deserve to be s doing wonders for their here mental health as well as their confidence. The Blue Devils turned to its best player in Wiktoria Galazyn against Abbott Tech and the senior came through with a solid effort all around the court. Plainville has other pieces to complement Galazyn's booming

The Semi-Annual Conversation Regarding Clocks and Time By: Francis Rexford Cooley

The first Sunday in November the vast majority of Americans reset their clocks by turning them back an hour as the country moved from Daylight Savings Time back to Standard Time. By the following Monday various disc jockeys, tv personalities, journalists, bloggers, and vloggers were all engaged in the semi-annual complaints about the "horrors" of changing the clocks. Some whine this is all for "the farmers", as if farmers who work with the rising sun of dawn through the waning light of dusk and have done so since the beginnings of civilization are concerned with clocks, because they are not. Others complain about the loss of an hour of daylight by moving to Standard time when in reality whether a clock is set, or even works. has no effect on the amount of daylight in a day. The use of standardized time is a recent innovation in human history and its application seems to have been lost on most of the pundits engaging in this conversation about changing the clocks so a brief recap of why standardized time was created and the purpose of the adoption of Daylight Savings Time may be in order.

Agrarian societies used the sun to tell time. Noon was the point when the sun reached the mid-point in the days sky. Work began with the crack of dawn and continued through until dusk. Time was local and measured by the sun upon a dial. It was not until the advent of industrialization and mechanized transportation of the railroad did the concept of Standard Time become a need. As railways stitched together Britain as well as the United States and Canada the need of standardizing time between towns become necessary. One needed to know when the 4:50 to Paddington would pass through their town so as to be on time to catch the train. Early trains could go through six, seven, or more different local time zones in which their clocks were often ahead or behind the recognized local time. The railroad companies, themselves, established a standardized time accepted for rail travel, first in Britain in 1840 and then in the United States and Canada in 1883. The British Parliament adopted Greenwich Mean Time by statute for the whole of the country not just the railroads in 1880. The United States passed the Standardized Time Zone Act in 1918 as part of the war effort for the First World War.

It would be the First World War that brought the idea of Daylight Savings Time (DST) into use. Congress as part of the war effort implemented the first use of DST in order to save on the use of fuel to produce electricity. By shifting the clocks an hour ahead urban industrial workers would have more of their active day in daylight thus reducing the need for electric lighting and saving fuel for the tanks, trucks, planes, and ships fighting the war in Europe. DST proved very unpopular with many, including the farmers, and was repealed in 1919 shortly after the end of the war. DST would not be brought back into use until the Second World War, once again to save fuel

and energy for the war effort rather than on electric lighting. The Chicago Cubs went so far as to donate the lights they had just purchased for Wrigley Field for the war effort and to save electricity. The Cubs continued to play exclusively day baseball at home until 1988.

The extended use of DST through the war years made it more acceptable to Americans in the northern tier of states as they became more used to extending daylight hours in the summer trading a rising sun of 4AM for a setting sun of around 9PM. The southern tier of states found little use in DST since they saw a much smaller swing in the amount of daylight during the year. It would be in the 1960s when Congress would force the States into adopting a standardized DST across the country for the "convenience of commerce." Arizona was allowed to opt out as its use of Standard Time year round merely meant the state shifted from the Mountain Time Zone in the winter to the Pacific Time Zone in the summer with no real inconvenience to commerce along with Hawaii well separated from the lower forty-eight by half the Pacific.

It would be the Oil Embargo of 1973 which pushed DST yearround in the hopes of saving energy. Implemented in January 1974 yearround DST proved to be a failure as the benefit of a later sunset was more than offset by a late rising sun of near 9AM in the more northern sections of the country. Kids going to school in pitch black morning made for awful optics and in reality little energy if any energy was saved as the shift in the clock increased energy consumption in the morning more than offsetting any savings in the late afternoon. Congress restored Standard Time that October. Since then, Congress has tinkered with the clocks pushing the start of Standard Time to Early November instead of the last weekend of October and the start of DST into March instead of Early April. The promised energy savings are rather minor in both cases.

The purpose of DST is to save energy, which it does in the northern states of the country during the six months of light (Spring Equinox to Autumn Equinox), its use year-round has been an abject political failure as there is no benefit to commerce. The system currently in place of Standard Time in the Winter and Daylight Savings Time in the Summer maximizes the economic benefits of saving energy in the northern half of the country while maintaining the "convenience of commerce" by keeping uniform and structured time zones throughout the United States for the shipment of product and people by various modes of transportation as Standard Time was created to do. Should the United States choose to stop resetting the clocks in the Fall and Spring then the default time will be Standard Time rather than DST as both experiments with year-round DST in 1918 and 1974 were abject economic and political failures.

Dear Editor,

Connecticut has experienced harsh winter weather, decades of infrastructure disinvestment, and transportation pipelines that no longer meet the needs of the population. Connecticut's aging infrastructure needs serious repairs and modernization. Across our state there are 248 bridges and over 2,100 miles of highway in poor condition. It is reported each driver pays \$711 per year in costs due to driving on roads in need of repair. Additionally, Connecticut residents who take public transportation spend an extra 130 percent of their time on commutes. From potholes to chronic traffic, Connecticut's infrastructure is currently rated one of the worst in the entire country.

For the people of Connecticut's Fifth District, the passage of the Infrastructure Investment and Jobs Act is welcome news.

The Infrastructure Investment and Jobs Act includes \$3.5 billion to overhaul Connecticut's bridges and highways, which will improve commuting and travel experiences for residents. The passage of the Infrastructure Investment and Jobs Act represents the largest long-term investment in our infrastructure and competitiveness in nearly a century. older brother to Mark by four years. Several members of the family are involved with police departments throughout the state and, according to Mark Catania, Matt Catania made them all very proud and "meant the world" to them.

"I guess you could call us the blue bloods of Connecticut – we can't sing or dance so we had to do something," said Mark Catania. "Our father is a retired Rocky Hill police officer who was on the job for 25 years and we had several uncles and cousins who were involved since I was a kid. They inspired me to get into the job. I had worked in the corporate world for 16 to 17 years before starting my career in the Middletown police department. I worked there for a year-and-a-half before being hired full time in Glastonbury in Nov. 1996. I'm now the captain, second in command, and Nov. 18 will be my 25th anniversary there."

Mark said that he, Matt, and their younger brother Robert, who is a retired Police Lieutenant from Rocky Hill and is now a sergeant with Central Connecticut State University's police department, would often speak to one another, collaborate on ideas or "bounce polices off each other." In addition, their brother Glenn is a retired Hartford Police Officer and three of Matt Catania's four children have gone on to become police officers. Matt Catania Jr. is a police officer in Canton, his daughter Gabriella serves in Bloomfield's police department and his son Nicholas is a police sergeant at the University of Connecticut. Mark Catania described Matt Catania as a "mentor" to him. "He was the go-to guy," said Mark Catania. "He knew how to solve everybody's problems and answer everyone's questions," he said. "If didn't know the answer, he'd get it get for you. I feel that he modeled the way he acted as chief after the way he was as a family member. He never turned anyone away and always had open door. Even if didn't agree with you, he respected your opinion. That was why he was so successful as a chief, a brother, a father and as a husband." Mark Catania said that his brother's legacy will endure

long after his death. The Matt Catania Scholarship Fund was set-up this May to support Plainville High School students pursuing a career in criminal justice or law enforcement.

"The Capitol Region Council of Chiefs made a huge donation to the fund," said Mark Catania.

Mark Catania said that his family still has a connection to Plainville and "watches the goings-on from afar." Mark Catania was one of the candidates to succeed his brother as police chief. Ultimately though, Eric Peterson was appointed the interim chief for six months.

"I wanted to continue the family legacy, but it ultimately became a political struggle," said Mark Catania. "We want to ensure the policies and the type of policing that Matt put forward can be sustained and ongoing there. In 2010, when Matt was hired, he changed the culture of the Plainville Police Department. He delivered a level of service to the town that Plainville had never experienced before. He brought school resource officers into schools, revived the K-9 program, and followed up with complainants. He made the Plainville Police Department into a premiere police department."

Mark Catania said that Nov. 20 is the

anniversary of Matt Catania getting sick and going to the hospital from an illness that ultimately would claim his life on March 10 of this year.

"Now that we are coming into the holidays, it's extremely rough," he said. "Matt was the focal point of Christmas parties with his sense of humor, oneliners and impersonations. His loss is an ongoing struggle; not a day goes by that someone doesn't talk about Matt. It's still very raw. His death came so far out of left field for us. The shock will never wear off." Mark Catania said that Matt Catania will never be

forgotten by the family or by those in the ranks of law enforcement.

Mark Catania is one of eight siblings in the family that included the late police chief, with Matt Catania the

Matt Straub

Matt Straub graduated from Plainville High School in 1996. Everyone who knows him would say he has so much passion for Plainville and truly bleeds blue. His work with the Plainville Athletic program began in 1991 as a seventh-grader. He worked closely with football statistician, Tom Arcari compiling defensive statistics for the Plainville Varsity team. Matt continued

his involvement during the springtime and was the scorebook keeper for the Middle School Baseball team, then eventually becoming the high school varsity keeper throughout his four years at Plainville High School.



Naoemi Villafane Raimondi

A talented and published author, 'Visualize Positive Results' whose athletic background became the impetus behind a career path that allowed her to achieve excellence in many unique athletic disciplines graduated from Plainville High School in 1996. During her high school career, Naoemi earned eleven varsity letters, four each in both Soccer and Track and Field and three

in Cheerleading. In Soccer she was selected All Northwest Conference and Most Improved during her senior season and in Cheerleading she was awarded the Team Spirit Award also during her senior year. However, it was in Track and Field that she drew the most accolades. Naoemi's specialty was the 100 Yard High Hurdles and during her Junior and Senior years she ran undefeated in dual meet competition. She also was part of a school record setting 4 x 100 relay team along with HOF member Jill Giannini that established the new benchmark. Additional honors followed including being named All Northwest Conference and All State 1994-96, participating in both the State Open and New England Championships and Co-Captain of the 1996 Class M State Champion Outdoor Track Team.

The 1958-59 Plainville High School Basketball team battled its way to the Class "B" State Championship title. Along the journey with two starters missing due to illness their only blemish was a loss to Southington. Making excuses was never the mantra of this era of Plainville basketball and the talented Blue Devils used this loss as motivation to help them capture the CVC Championship, a State Championship and a remarkable 24-1 overall record. This impressive won \lost record was especially noteworthy since they beat state power East Haven twice during the regular season, snapping their 64 home game win streak! In the 1950's East Haven dominated the State Tournament with multiple state championships on their resume.





Todd Goodall

Todd Goodall was an outstanding two-sport athlete in soccer and golf while earning the distinction of being captain for both teams. He earned varsity letters in both sports, compiling a total of eight varsity letters. During the fall Todd was an outstanding soccer player. According to an interview in the New Britain Herald, HOF coach Greg Ziogas, stated before his sophomore season that "Goodall is a good one" and he wasn't wrong. He was the leading goal scorer his junior and senior years along

with being the total points leader his senior season. During his senior year he led his team to the State Tournament with a record of 7-5-3.



Shawn Curtis

Shawn Curtis graduated from Plainville High School in 1993 as a two-year captain of the wrestling team and arguably one of the most decorated and feared wrestlers in Plainville history.

During one of the more successful decades in Plainville sports history Shawn recorded some of the finest accolades of any athlete. He was elected captain of the wrestling team in both his junior and senior year, which is a testimony to the amount of respect he garnered from his teammates and coaches during his wrestling career.



Jennifer Dabrowski Hover

Jennifer Dabrowski graduated from Plainville High School in 2004. She scored 1,060 points despite playing with a torn ACL her entire senior year. A four-year varsity starter, she guided the team to a Class M State Championship as a freshman. A phenomenal athlete, the teams won

60 games during her career. Her dribbling skills dazzled the crowd as they chanted "She's a freshman," with vigor. Her perfect 6 for 6 shooting from the foul line during the waning minutes of the championship game sealed the victory. The consummate point guard, she could dribble, drive and shoot. As a result, she was a 4-time All-Northwest Conference selection. A true scholar athlete, she garnered All-Academic honors as well.



Thomas Ferguson

TJ Ferguson was a dedicated and tireless swimmer and diver whose incredible work habits were the impetus for his unique ability to accomplish the rare double feat of being named Class S All State twice with two third place finishes in the one hundred yard breaststroke in 2000 and 2001, a second place finish in the 200 yard freestyle relay

The 2001 Class M State Champions were the first female team to win a state title for Plainville High School. After compiling a 15-5 regular season record, they were seeded eighth in the Class M tournament; the team beat the #1, 2, 4, 9 and 25th seeds to finish the season with a record of 21-6. Of the six games they lost, two were to another state championship team and three were to a state semi-finalist team

in 2001, a fourth place finish his junior year and a State Championship finish during his senior year in one meter springboard diving as well. During his incredible career at P.H.S. he established school records in both events.

Phil Rothkugel

Phil Rothkugel was a great teammate who was a four-year starter and letter winner on the Plainville High School Baseball team during 1998-2002. He was a two-time All State (2001 and 2002) nominee and named to the All Northwest Conference team all

four years of his career.
