Town Manager Robert E. Lee ~ Report to the Town Council May 1st, 2017 Town Council Notes

Budget Vote Results

 Last Tuesday, Plainville residents overwhelmingly approved both the General Government and Board of Education Budgets as recommended by the Town Council.

The General Government Budget was approved with 461 voting "yes" and 182 voting "no". Almost 72% of those voting for the General Government budget voted "yes".

The Board of Education budget was also approved with 429 voting "yes" and 213 voting "no". Almost 67% of those voting for the Board of Education budget voted "yes". The turn-out for the budget vote was 5.6%. The next step for the Town Council is to set

the mill rate for FY18 so that the tax bills can

be mailed by July 1st.

The State Legislature continues to deliberate on their proposed budget. Their budget decision is fairly important because approximately 20% of Plainville's revenue comes from the state. Up until this point in time, Town staff has recommended using the Governor's proposed

To date, the Appropriations Draft Budget and the Republican Alternative would result in slightly increased revenues to Plainville if adopted.

revenue amounts when presenting the potential

The Town Charter states that the Town Council shall fix the tax rate within 30 days after the annual Budget meeting. Town staff will prepare a recommendation for setting the mill rate at the May 15th meeting.

School Renovations Project Update

mill rate change for next year.

A Public Hearing was held on the School Renovations Project a week ago on April 24th. The Hearing was lightly attended. Those who spoke at the Public Hearing mainly spoke in favor of the project. One resident asked for a clarification of the status of state reimbursement for the project. The State continues to assure Plainville that the project will receive 65% of eligible expenses for the project if an application is filed by June 30th. The project consists of two items. The first to make renovations and updates to Wheeler Elementary School. The project would "renovate like new" the building and bring it up to standards similar to the other two elementary schools in Town.

The Capital Projects Building Committee, after reviewing a scaled down project, is recommending that the "renovate like new" approach be pursued because it will allow the project to access additional grant funds and to have a school that will not need any additional improvements for the foreseeable future. The State is encouraging Towns to pursue updating existing buildings rather than new construction. The Capital Projects Building Committee is supportive of a plan that would result in the "best bang for our tax dollars".

The second part of the project is to replace the pavement at the high school including the parking lots and around the athletic fields. Numerous cracks are evident and the pavement has exceeded its useful life.

Overall, the project is estimated to cost \$25.26M. With state reimbursement, the net cost to Plainville is estimated at \$13.15M. This net project cost can be absorbed in the Debt Service portion in the Town budget without increasing the current budgeted amount. This

is due to the retiring of previous debt for other projects.

In conclusion, there is no argument that significant work needs to be done at Wheeler School and also the pavement at the High School. The Building Committee has been working for several years on proposals that would be in the best interest of our community in the long run. The recommended project would address the needs and the resulting cost impact to Plainville would be minimized due to state grants and the Towns' favorable debt schedule.

 There are items under New Business which, if approved, would set the referendum date for Tuesday, 6th and authorize the distribution of an explanatory text for the project.

Town Manager Robert E. Lee ~ Report to the Town Council May 15th, 2017 Town Council Notes

Town Council Notes May 15, 2017

General Obligation Bond Sale

- The Town recently sold \$3M in Bond Anticipation Notes as part of the Roadway Bond program. Bond Anticipation Notes or BANS are used as a temporary financing vehicle for large projects until the projects are either completed or have reached a certain monetary threshold.
- Five bids were received and the low bid was submitted by TD Bank in the amount of 1.22%. The note will be for the period of May 17th to February 15, 2018.

Public Information Session Regarding Valley Water

- A Public Information session to discuss the results of the water tests will be held on Thursday, June 8th at 7:00 pm in the Middle School Auditorium. Representatives from the Public Utilities Regulatory Agency (PURA), the Department of Public Health (DPH), the Plainville Southington Health Director, and Valley Water Company will attend and be available to answer questions regarding the quality of the water and the operation of the water system in Plainville.
- Residents will have the opportunity to make comments and ask questions from the state officials that oversee the operation and water quality that is supplied by the Valley Water Company.
- I anticipate that this will be a very informative meeting and I encourage all interested residents to attend the Public Information session on June 8th.

Mill Rate Recommendation

- The State Budget is still being negotiated in Hartford and there is much uncertainty how much Plainville will receive for education and other municipal grants. Additionally, while there does not seem to be much support for the Governor's proposal to have municipalities pay a portion of the Teacher's Retirement Fund, the legislature has not yet fully eliminated this possibility.
- Finally, the current legislation mandates that on July 1st the mill rate cap for motor vehicles be reduced from 37 mills to 32 mills. Several key legislative leaders have said that they do believe that this will change and that the motor vehicle mill rate will not be lowered. Because Plainville's mill rate will be above 32 mills, this decision will need to be known to the Town Council before setting the mill rate.
- For all of these reasons it is my recommendation that the Town Council wait until either the State finalizes their budget or the end of the Legislative session, whichever comes first, before setting the mill rate.
- The Legislative session ends on Wednesday, June 7th. That should still leave enough time to have the tax bills prepared and ready for mailing by July 1st.

PETIT / MARTIN SUPPORT REPUBLICAN PROPOSED BUDGET

Stand Up for Taxpayers, Community Hospitals State Representative William A. Petit, Jr. (R-22) and State Senator Henri Martin (R-31) stood arm-in-arm with their House and Senate Republican colleagues and put forward a balanced, no tax increase budget which sets the Connecticut on a new fiscal course.

The proposed budget comes as Connecticut stands on the brink of fiscal disaster and faces a \$3 billion budget deficit that seems to grow by the day. The budget provides a blueprint to move the state away from years of tax increases and unsustainable budget that have cost Connecticut businesses and residents.

"Given the dire fiscal situation that our state is in, I am proud to stand behind this budget, which closes the state budget deficit without raising taxes on residents and also cuts spending," said Rep. Petit. "This budget also restores funding for Plainville and New Britain, and rejects the governor's proposal to pass along the \$400 million in teacher's pension costs, which ultimately would have led to increased property tax rates."

"While other states have recovered from the 2008 recession, Connecticut's high taxes, onerous regulations, and anti-business policies are strangling efforts to restore jobs and improve the economy," Sen. Martin said. "This budget starts the process of reviving the state and putting it back on the path toward fiscal health by making government smaller and more cost effective."

Unlike the governor's budget which raised taxes by \$200 million and the legislative Democrat plan which would raise taxes by over \$400 million, the Republican plan DOES NOT raise taxes.

The Republican budget spends \$700 million LESS than the Democrats' budget and \$313 million less than the governor's budget.

Other Budget Highlights include:

- Restores funding for Care4Kids
- Restores funding for senior Meals-On-Wheels
- Consolidations of state agencies
- Eliminates funding for UConn branch of FastTrack
- Eliminates taxpayer funded campaigns
- Mandatory Approval of labor contracts by the General Assembly
- Requires \$700 million in union concessions
- Cancels bonding \$250 million for the XL Center
- Enact a constitutional Transportation Lockbox
- Phases out the income tax on pensions and annuity
- Exempts social security from income tax for middle

According to the latest report by the Office of Fiscal Analysis, the state budget is projected to run a \$1.7 billion in deficit in 2017-18, and \$1.9 billion in the red in 2018-19, according to Governor Malloy, for a combined biennial shortfall of \$3.6 billion.

If the April income tax estimates hold, the deficit forecast would rise to \$2 billion in 2017-2018

MAINTENANCE OF PRIVATE EASEMENTS

What happens when it is impossible to get onto a piece of property without crossing another property? When this arises there is a need for a private easement or right-of-way. But who is responsible for the maintenance of the pathway... the property owner that is boxed in or the property owner that has the easement in their property? Public Act No. 14-67, effective on October 1, 2014, has provided a straight forward outline for such maintenance issues.

The owner of any residential real property that benefits from an easement or right-of-way, the purpose of which is to provide access to such residential real property, shall be responsible for the cost of maintaining such easement or right-of-way in good repair and the cost of repairing or restoring any damaged portion of such easement or right-of-way. Such maintenance shall include, but not be limited to, the removal of snow from such easement or right-of-way. This is the language directly from the Public Act. The party that needs the easement has to pay for the maintenance. Seems to be pretty fair that the party who needs the easement maintains it.

When multiple parties need an easement or a right-of-way to get to their properties the Act says they split the cost based on the proportion of the benefit they receive. So, if one property only uses 20 feet of the easement and the other property uses 100 feet of say a 120 foot easement the maintenance cost is based on those figures. It would be unfair to split the maintenance 50/50 in that scenario. However, parties are free to contract a different split of the costs and that agreement will be controlling over the Act.

Easements and Rights-Of-Way are going to become more and more commonplace as people multiple and spaces get tighter. Especially in regions like New England where space is already at a premium. So when buying or selling be sure that you are aware of possible land rights.





Tips for keeping your **Identity Safe**

The digital world continues to become a larger part of our lives every day. Despite our best efforts to maintain our identity and security, there is no shortage of criminals out to scam us of our money, personal information, and our identities. In order to navigate all of these risks safely, here are some tips to help you stay

Your behavior is critical.

You must look at everything you see and hear with skepticism. From phone calls, to emails, to social media and websites. Everything must be considered suspect until confirmed to be valid. By far the most successful means used by criminals to scam people is social engineering. It's the oldest trick in the book. You've heard the stories about people getting calls from those claiming to be from the IRS claiming that you owe taxes, the power company claiming that if you don't pay your electricity will be shut off, and Microsoft claiming you have a virus that needs to be fixed. You may have seen emails that appear to be from people you know asking for help, from your bank or credit card company claiming a problem with your account, from your email provider claiming that you need to verify your account information. The methods may have changed, but the tactics haven't changed.

All of these scams count on trusting and helpful people unaware of the lengths that criminals will go to in order to trick them. They play on your fears and protective instincts. Keep your guard up at all times.

Handling Email.

Email can be easily forged to make it look like it is from someone you know and trust. In general, look for poor grammar, misspelled words, or poorly formatted messages. Look at the email address in the FROM: section of the email. It may say SomeBank, but if the email address says customerservice@SomeBank. irtwij.jp don't trust it. Many times, this address will not match the sender. But that is not always the case.

Do not click on links in ANY emails unless you are absolutely certain of it. Even though the link says http://www.SomeBank.com it does NOT mean that is where the link goes to. In many cases if you point your mouse arrow over the link without clicking on it, you'll see a bubble pop up that has the real link in it. If it does not match exactly, it cannot be trusted. DO NOT click on it.

If you do end up clicking on the link, you may be taken to a website that looks identical to www.SomeBank.com 's page. Website's can be very easily copied and made to look just like the real thing. Close the page. Don't enter any information into these websites.

Visiting websites.

It is hard to know what is real and what is suspicious on the internet. Visit trusted websites. Stay away from questionable sites. Stick to the more trusted websites. Do not trust ads. Many websites rely on advertising to pay the bills. Many websites mix in ads among the real content without differentiating content from advertisement. Be careful what you click on. Don't fall for the salacious

Most internet browsers like Microsoft Edge, Google Chrome, Firefox, and Safari will show you whether a website is secure. Pay attention to the address bar across the top of the window. The address bar is the place where you see the website's address. On this address bar is an indicator of the websites level of security. Some show green text, some show an image of a locked lock. Look for sites that use https in their addresses. The s is for secure. But, not always. Stay vigilant.

Make sure the address is correct. Criminals will register common misspellings of popular websites to trick those of us with poor typing skills.

When navigating a shopping website, keep an eye on these indicators. A questionable website may appear to be safe until you get to the page where you enter your credit card information. Suddenly, you may end up on a different website that may not be secure.

All of this can make folks want to just avoid technology all together. If at any time you do not feel safe, err on the side of caution. Find a safer way to do what you want or verify, verify, verify.

There is more to cover. I will be back in future editions with more tips and tricks to make your digital life safer. Jim

On June 6th the voters of Plainville will vote on moving forward with two important projects through a town wide referendum, the Renovate like new of Wheeler Elementary School and the parking lot at Plainville High School. Therefore, no tax increase due to these projects.

The time is now. We are in a unique situation and should take full advantage of this opportunity. Please get out to the firehouse on Tuesday, June 6th and vote yes for these two very important projects.

Well folks, We need some changes in the attitude of the Plainville education administration. I feel that they have no sense of fiscal management. A person would get the impression from all the unnecessary capital projects, that money is of no concern to them.

First we have a perfectly fine football field, and what do they want? An artificial turf field embedded with crumb rubber that is potentially hazardous to our children. Next we have a running track that is usable, what do they do? Install a new track that is now not in usable condition. Next they insist that we demolish a fine old school building, at the cost of many millions of dollars, now all we have is open wasted space.

They do not realize that most of the Plainville taxpayers do not earn the \$90 to \$160 thousand dollars salaries that many board of education employees do. Just to mention, the Board of education employees' salaries and benefits total more than \$29 million dollars a year.

The taxpayers of Plainville are forking over more than \$4.7 million dollars every year just to keep up payments on the loans for all the capital projects that have been approved in town.

I am urging all the Plainville voters to come out on June 6th and vote down the 23 million dollar renovate as new Wheeler school project, tell the town that we only want to fix what is needed, and at the same time we can add air conditioning so the employees will not get over heated, frustrated and feel discomfort in their work environment.

Petit Hails Passage of Proposal Allowing the Return of Prescription Drugs to Pharmacies

HARTFORD- State Rep. William A. Petit, Jr. (R-22) voted in favor of a bill in the House of Representatives this week that looks to allow certain state pharmacies to accept and dispose of unused prescription drugs.

"Across our state and the nation, we continue to see the effect of the opioid crisis, including a dramatic increase in the amount of deaths from overdose. Just recently, I toured a local substance abuse treatment facility which substantiated that these concerns are something that we are also dealing with locally in the towns of Plainville and New Britain. This measure is one way in which we can proactively work to combat the growing opioid crisis," said Rep. Petit, a member of the legislature's Public Health committee. Currently, prescription drug drop boxes in Connecticut are located in local police stations.

The legislation, HB 5077, An Act Concerning the Return of Prescription Drugs to Pharmacies, allows for Connecticut licensed pharmacies to accept and dispose of unused prescription drugs. The bill also allows for the potential for cooperative agreements between pharmacies and local law enforcement, which should help independent and rural pharmacy locations.

The bill has the support of the Connecticut Association of Community Pharmacies.

According to Governor Malloy, Connecticut saw an increase in the amount of unused prescription medications that residents dropped off at collection boxes during 2016, with the state collecting a total of 33,803 pounds worth of various medications throughout the year. That amounts to a 43 percent increase compared to the amount that residents dropped off in 2015, when 23,651 pounds of unused drugs were collected by the state.

The final rule on the Responsible Drug Disposal Act of 2010 provided by the Drug Enforcement Administration (DEA) in September of 2014 expanded the authority of authorized hospitals/clinics and retail pharmacies to voluntarily maintain collection receptacles. These receptacles would still be subject to regulation and protections under the law. This bill will merely give pharmacies the option to participate as a collection site, not require it, and would likely help to get more prescription drugs off the street from folks who would otherwise feel uncomfortable returning them to the police directly.

The bill passed unanimously out of the House of Representatives and awaits further action by the state Senate.

Rep. Petit Tours Farrell Treatment Center



In an effort to better understand the local impact of the state's opioid crisis, State Rep. William A. Petit, Jr. (R-22) recently visited Farrell Treatment Center, a nonprofit substance abuse treatment facility, located in New Britain. Rep. Petit was given a tour of the facility by Executive Director, David Borzellino (at right) and Board of Directors Member, Foster White.

Originally, serving as a dormitory for the nuns who taught at nearby St. Mary's, the building was converted into a sober house, and has evolved into the substance abuse treatment facility it is today. Farrell offers intensive outpatient treatment while Farrell's intensive residential treatment offers 24-bed residential treatment services utilizes a Department of Mental Health and Addiction Services (DMHAS) 28-day program. Borzellino indicated that they have seen an increase in clients seeking services for addiction to opioids, citing that they typically make up to 75% of Farrell's client population at any given time. Borzellino also noted the increase in deaths from opioid overdoses.

Memorial Day — Decoration Day?

About three years ago, my wife and I went on a trip to Maryland. There were two tour buses of us. We went to the Civil War battlefield memorial, Antietam.

Antietam was one of the major battles of that war, with over 135,000 troops involved. This battle between the North and South — Lee tried to invade the North and the Union moved to stop him — was one of many during the war where thousands

of Americans were killed, maimed and wounded both physically and psychologically.

The number

of men killed in combat during this conflict astounded all Americans, and it took them two or three generations to overcome the numbers of war dead.

Antietam was hell on earth. Over 22,000 troops were killed in a single day. A regiment of Connecticut soldiers were a major factor in the battle and suffered over 70 percent causalities that day. The day of the battle, September 17, 1862, was the first day of combat for the regiment and the last day of life for many Connecticut men. Several towns in the state lost many of their sons and brothers and fathers in Maryland. The carnage was so gruesome the battleground became a mass graveyard and today is a war memorial.

President Lincoln could clam a union victory, even though the battle was a standoff, a stalemate; he wrote an executive order—the Emancipation Proclamation. Slavery, after the proclamation, was admitted as a major factor in the war and kept the European powers from supporting the Southern cause.

The celebration of Decoration Day started in 1868, the day people would decorate the graves of their fallen soldiers. People from Connecticut would take a train to Maryland

and pay their respects and remember their men lost to war. They would grieve.

After World War II, America brought the North and South together by declaring May 30 Memorial Day, making the name official just before the date was moved to the third Monday in May in 1971.

We remember the men and women who perished, protecting the people of the American Republic.

Healthy-Behaviors

Let's Do This! Sustainable Approach

Finally! Farm fresh in season fruits and vegetables will soon be overflowing at farmer's markets, grocery stores and hopefully, in our gardens.

Personally, I've been waiting all winter for a really good cucumber. They are terribly sad looking and tasting when out of season. According to an article by Dr. Mercola, cucumbers are a powerhouse of nutrients and these health benefits: Anti-inflammatory that helps to improve memory, anti-cancer properties, natural antihistamines, freshen breath, manage stress, support digestion and help maintain a healthy weight.

That's quite a lot for a veggie normally relegated to be a small part of a salad. This valuable member of the Cucurbitaceae family deserves to appear more often in our diets. I love this crunchy cool veggie in smoothies and as a replacement for a cracker for an easy appetizer. Just add your favorite soft cheese spread or hummus and top with an olive – so delicious. Great on sandwiches as well.

Other fruits and vegetables that are plentiful now are fresh peas, beets, spinach and strawberries.

I just can't get enough of beets these days as well. They add texture and sweetness to a salad and are delicious in my smoothie. Beets provide antioxidant, anti-inflammatory and detoxification support. The greens can be prepared like spinach and are high in vitamins and minerals.

Some of my favorite places to shop for garden delights are the Plainville Farmer's Market and Sub Edge Farm in Farmington. No time to get to the market? We are lucky to have the farmers come to another favorite, our own hometown grocer, Gnazzo's. They source locally grown fruits and vegetables so we can have a one stop healthy shopping experience.

When everything looks so good, it's easy to buy more than we might reasonable consume. In the past, I felt pretty bad about throwing away good food that stayed too long in my refrigerator. Here are some tips to avoid this.

Storing herbs, such as parsley, cilantro, basil, rosemary, thyme and the like.

Best Method: Snip off ends when you get them home and place in a mason jar with 1-2 inches of water. Cover loosely with plastic bag. Change water every few days.

Good method: Remove herbs from plastic grocery bags, Place on a paper towel, and pat to remove excess water. Put into zip lock and add a few while paper towels to absorb any moisture that might occur. Put in vegetable drawer in refrigerator.

Longer term methods: If you still have more produce than you will eat in a few weeks, then dehydrate, freeze or make a broth.

Dehydrate: No worries if you don't have a dehydrator. Wash the herbs and pat with paper towel until completely dry. Remove stems and place the flowers on a large baking sheet and put in oven on lowest setting. Continue to check until completely dry and slightly crispy. Once cooled, you can break up dehydrated pieces and put in a jar and use as you would any dried herbs that you might buy at the store, but at a fraction of the cost.

Freezing. Wash, blanch, dry and then remove stems. Chop and place in ice cube tray. Top with olive oil or water. When frozen, remove from tray and put in zip lock bag. Or you can freeze directly in a zip lock. When ready, add a cube or two to sauces, soups or other recipe.

Make a broth. Chop any herbs, cut carrots, celery or other vegetables on hand. Add water and seasonings to make a broth for use now or freeze for later.

Composting: If you have a garden, consider putting them in a compost pile or container instead of throwing them away. If you don't have the space or inclination to compost, then put these vegetables in a blender with a little water, mix and add to your watering can to provide your plants with added nutrients.

Rule of thumb for leafy greens: Don't store leafy greens in plastic grocery bags or loose in refrigerator. Make sure you use a paper towel to remove moisture. I like to remove the leaves of kale from the stem and then place in a container lining each layer with paper towels. Making a quick smoothie in the morning is much easier this way. Adding frozen strawberries to the smoothie makes a very refreshing drink as well.



While the major over-air broadcasters held contracts for MLB, the NFL, and NBA ESPN put all sorts of sports from foreign soccer and rugby to college football, baseball, softball, lacrosse and numerous other live and taped sporting contests. ESPN's news program, SportsCenter ran at Noon, Six, and Ten or Eleven with repeats in the morning, but ESPN's bread and butter was sports in the morning, usually taped, early afternoon, taped or college live, late afternoon, again taped or college live, evening, the premier live sports event, and late-night from the West Coast either starting at Eleven or Midnight Eastern Time. That ESPN, of sports and more sports, is long dead.

A quick look at ESPN's schedule for the Week of May 15th through 19th (Monday-Friday) illustrates the lack of actual sports on ESPN and ESPN 2, its sister channel. On Monday the 15th only ESPN has actual sports on with a single MLB game on at 8PM EDT. ESPN 2 joins the fray televising sports on Tues. the 16th with an hour of Poker while ESPN shows an NBA playoff game. On Weds. ESPN shows one MLB game while ESPN 2 shows four hours of "Drone Racing" both starting at 8PM EDT. It is finally on Thurs. that ESPN shows more than a single sporting event when it has an SEC Baseball Championship game on at 7PM followed by the Diego De La Hoya v. Erik Ruiz boxing match. ESPN 2 follows suit as well with a WNBA game at 7PM leading into the SEC Track and Field Championships at 9PM. It is not until Fri. the 19th that ESPN 2 shows any sports before 7PM when it begins its all-day broadcast of NCAA Women's Softball Regionals at Noon. ESPN doesn't begin its live sports broadcast until 7PM that Fri. when it also broadcasts the first of two NCAA Women's Softball Regional games. The rest of the ESPN and ESPN 2 broadcast schedule is full with people talking about sports, or sports documentaries, or news shows.

Simply put ESPN has forgotten what made the network in the first place, showing sports. For a twenty-four hour cable channel devoted to sports ESPN only showed approximately 19 hours of sports over 120 broadcast hours. ESPN 2 is a little better showing approximately 20 hours of sports (including 5 hours of Poker and "Drone Racing") over the same 120 broadcast hours. Radio provides hours upon hours of sports talk every day. The internet provides instant updates of sporting events from across the globe. What made ESPN successful in the first place was that it showed actual sports. Maybe ESPN should considering doing that once again.

The Town of Plainville's Conservation Commission is leading a hike in Sunset Rock State Park for National Trails Day. The hike will begin at 9:00AM on June 3rd – National Trails Day. The 5 mile hike will begin at the intersection of Black Rock Avenue and Esther Street in New Britain just over the Plainville townline. We will start on the Metacomet Trail then take a spur up Bradley Mountain. There are some fairly steep and rocky sections so the hike is not geared toward beginners. The moderate climb is rewarded with views of Crescent Lake, Meriden Mountain and, on a real clear day, Sleeping Giant. The trail we will take also skirts around the edge of the proposed Tilcon quarry expansion. You will be able to see the area up close during the hike.

There are reports from the past of a rock named Boy Rock in Sunset Rock Park. We have a general idea of where it is. If we have the interest, we may venture off the beaten path to search for it. Better yet, if someone knows where it is, we would love to rediscover it.

The hike will continue to Ledge Road in Plainville. Hikers wishing to shorten the hike can arrange pick up there, however cell phones will be required to coordinate the effort since there is virtually no parking on Ledge Road.

We will then retrace our steps back to the start of the hike.

Although geared toward Plainville residents, all are welcome to participate. Participatants should take tick and sunscreen precautions.



I am holding a pop-event June 5 at Little River Restoratives on 405 Capital Ave. in Hartford, starting at 6:00pm, and was wondering if you'd be interested in using me as an anecdote for a story on the rise of pop-up events in Greater Hartford. I would love for you to come June 5 and taste some of my food!

Just for a little background, I am a Connecticut native who went to culinary school at the Culinary Institute of America in New York, and worked at some of New York City's top restaurants, including Picholine, Bouley, Le Bernardin, and Vaucluse during my six years living in the Empire State. I also made great use of the sparse time that chefs in the city have for themselves with the development of my website www.pursuitofpassion.net. The site is a culmination of culinary concepts based on the knowledge and experience I gained through my time in Michelin starred kitchens. The unique aspect of the site is that the "recipes" are written as stories and vivid descriptions detailing the inspiration for each dish along with the logic behind each step of the process. The concepts from this website became part of a menu that I developed and executed for a private dinner party in Tribeca, as I served a ten course tasting menu for thirty guests with Deborah Fishman- of the FED dinner event platform.

The recent dinner event at Little River Restoratives in Hartford will be open to the public and involves an a la carte style menu inspired by the Pursuit of Passion website. This allows guests to sample many different bites of gustatory delight, with the freedom to customize their experience.

The guest is always first and foremost in my thought process while cooking; as I like to put it: My passion is cooking, but my purpose is to create memories for the guests!

Chris Parrot is the owner of Little River Restoratives as well as the Bob Ramen locations in Hartford and Plainville. As a certified sommelier, Chris will also be selecting several French wines to pair appropriately with my menu.

I moved back to Connecticut a few years ago to work at my cousin's restaurant -- Peppercorn's Grille in Hartford -- and recently took a job as sous chef at Avert.

I've been reading and enjoying your work since I returned to Plainville, Connecticut and would like to chat with you further about future columns about my new ventures.
