Liberty Bank Robbed

A Southington man who police say robbed at least one Plainville bank was tracked down to a Newington motel, where he refused to come out for a period of time before he was eventually taken into custody.

David Latino 49, is expected to face charges in connection with the robbery, Plainville police said.

The robbery was reported around 12:30 p.m. at the Liberty Bank on East Street. There, a suspect handed the teller a note, demanding cash. No weapon was displayed.

The suspect, who made off with an undisclosed amount of money, was described as a white male with an average build. He was wearing a baseball hat and mask.

Police said the suspect is believed to be the same person who robbed Liberty Bank two days earlier and possibly other locations.

Plainville police said their investigators developed Latino as a suspect. He was then tracked down to a motel in Newington, Plainville police said.

Late Thursday, Newington police could be observed at an active scene at the Carrier Motor Lodge. Multiple officers, including a SWAT truck, were outside the motel in the evening hours.

Plainville police said Latino eventually was taken into custody on charges unrelated to robbery.

American Rescue Plan Discussion

- Plainville will be receiving approximately \$5.2M under the American Rescue Plan (ARPA) passed by the U.S. Congress.
- Eligible uses of ARPA Funds include: to support public health response to COVID-19, address negative economic impacts from the pandemic, investments in water & sewer projects, broadband infrastructure, and replace loss of revenue.
- During the September 13th Town Council meeting, it was recommended that the Town Council form a planning group to recommend how these monies should be allocated.
- Such a committee could include Town Council members (2-3), the Town Manager and Assistant Town Manager, Public Works staff, Town Attorney, Town Engineer, and Regional Health Director.
- There is an item under New Business regarding the formation and the appointment of the members of the American Rescue Planning Committee.

White Oak Redevelopment Project Update

- At the September 13th Town Council meeting it was recommended that the Connecticut Brownfield Land Bank, Inc. be engaged to manage the DECD Remediation Grant for the White Oak property. The Land Bank has been involved in brownfield remediation grants throughout Connecticut for many years. They are very familiar with the requirements of the grant and all that is involved with working with developers to clean-up contaminated properties.
- The Land Bank has submitted a proposal for these services in the amount of \$58K. These costs would be paid through the Remediation Grant.
- There is an item under New Business to authorize the Town Manager to enter into a Services Agreement with the Connecticut Brownfield Land Bank, Inc. in the amount of \$58K.

Police Department Update

- Chief Eric Peterson is here this evening to give an update on the Police Department activities including a status of the Body Camera Policy and implementation.

Honor Heights Discussion

- Earlier this year I was contacted by several residents of the Honor Heights neighborhood about the possibility of having sewers installed to service their homes. This neighborhood consists of 82 homes that were built in the late 1950's and 1960's.

- Approximately 40 residents attended the meeting that lasted 1 ½ hours. Several different funding possibilities were discussed. One advantage of installing sewers now is because the roads in the neighborhood are scheduled to be repaved as part of Phase 2 of the Road Bond Program. Installing the sewers before the roads were repaved could significantly lower the project cost.
- A review of the Health Department records indicated that the average age of the septic systems in this area is 35 years.
- Unless there are objections from the Town Council, Town staff plans to send a follow-up email to those who attended the meeting to determine how much interest there may be to continuing discussions on a possible sewer extension to the Honor Heights neighborhood. The results of the feedback will be shared with the Town Council at a future meeting.

Affordable Housing Plan Development

- The State of Connecticut recently mandated that municipalities develop an affordable housing plan every five years. The initial plan must be submitted by next June.
- The Town recently was awarded a \$15K grant from the State to develop such a plan. Town staff issued an RFP to solicit proposals from qualified firms to complete a plan to meet state requirements. Five proposals were received.
- An interview panel consisting of Glenn Petit, Vice-Chairman of the P&Z; Garrett Daigle, Town Planner; and Matt Daskal, Assistant Town Manager interviewed the five firms.
- After the interviews were completed, the panel unanimously is recommending awarding the contract to SLR of Cheshire, Connecticut to assist in developing an Affordable Housing Plan for Plainville.
- There is an item under New Business regarding this recommendation.

Robertson Airport Concrete Work

- The Aviation Commission recently authorized the use of aviation funds to make improvements to the Administration Offices at Robertson Airport. Interstate Aviation is also contributing funds to the project as well.
- Renovations include exterior upgrades to doors, windows, entrances, (including ADA accessibility) and a rear public patio where people can observe the airport operations.
- The Roadways Department is also assisting in the project which will help to reduce the overall cost of the project.
- There is a significant amount of

new concrete work that is necessary for the project. Town staff has had difficulties in finding a company to perform the concrete work. Two proposals were received with the low bid being submitted by Terry's Concrete, LLC of Southington in the amount of \$48,620. Terry's Concrete has previously worked with Roadways and is able to coordinate timelines to meet Town needs.

- Town staff is recommending that the Town Council waive the bid process and award the concrete work at Robertson Airport to Terry's Concrete, LLC of Southington in the amount of \$48,620. There is an item under New Business regarding this recommendation.

Pickup Truck – WPC

- Joe Alosso recently requested that a 2003 GMC Sierra pick-up truck needed to be taken off the road because of significant structural issues. This truck was scheduled to be replaced next year.
- At my request, Joe Alosso was able to identify two recent CIP projects that came in under budget, namely the Mountainview Pump Station and the Odor Control Project. These two projects had enough savings to cover the cost of a pick-up truck purchase this year.
- Joe was able to locate a 2021 F150 single cab at Gengras Ford of Plainville under the State Bid price of \$29,983.70.
- Town staff is recommending the purchase of the truck utilizing savings from two completed WPC capital projects. There is an item under New Business that would authorize the purchase of a Ford F150 single cab pick-up truck from Gengras Ford of Plainville utilizing a State Bid price of \$29,983.70.

COVID-19 Update

- As of last Thursday (October 7th), Plainville remains in the "Red" category for COVID-19 cases with a 15.5 rate per 100K population. This is just above the "orange" category level. It is anticipated that Plainville will most likely be in a lower category next week.

Municipal Broadband Interest Survey

The Town of Plainville has launched an online broadband interest survey for residents and business owners. The purpose of the poll is to gauge public support for building a municipally-owned fiber-to-the-home (FTTX) broadband network that would offer connections to all town residents and businesses. Plainville property owners can access the survey and learn more at plainvillect.com/broadband or by going to the Resource Center on the town website and clicking the Broadband Interest Survey button. The survey will be live until June 1, 2022.

Plainville is currently working to deploy a municipal fiber network connecting town offices, wastewater treatment facilities, emergency services, and educational institutions in all four corners of the town the town center. infrastructure, including 12.5 miles of aerial cabling and three underground spans running beneath major highways. Installation of the municipal network opens the door for Plainville to efficiently build out a town-owned FTTX network.

Radicals in the White House

Elections have consequences. The election of Joe Biden as President has consequences. While Joe Biden garnered support as the “centrist” alternative to the Democrat nomination for President of avowed Socialist Senator Bernie Sanders President Biden’s administration is looking far more radical than “centrist” in its first near 300 days. Ms. Stone-Manning was involved in an eco-terrorist tree spiking incident on the Clearwater National Forest (CNF) in 1989 in which she “retyped, edited and mailed an expletive-filled anonymous letter on behalf of radical tree-spikers.” (Washington Times,

30 Sept. 2021). An EarthFirst! activist Ms. Stone-Manning avoided prosecution in the case by agreeing to testify against her fellow eco-terrorists who spiked numerous trees in the hopes of maiming (and possibly killing) loggers legally working CNF. Now some thirty plus years later she can implement her radical EarthFirst! agenda to the detriment of American economic interests throughout the West.

She essentially wants to end banking as a private enterprise. It, however, should not be shocking since Ms. Omarova was born in Kazakhstan in the then Soviet Union. Ms. Omarova attended Moscow State University in then Soviet Russia on a Lenin Personal Academic Scholarship. Such scholarships were reserved for party members, children of party members, and the like. The party, of course, was the Communist Party. Ms. Omarova has been forthright in her praise of the Soviet system regarding banking. It should be noted the Soviet economic system, Communism, did not fair well as its inherent flaws led to the collapse of the Soviet Union in 1991 after the demise of the Soviet Communist empire in Eastern Europe from 1989 to 1991. The Biden Administration is proposing to place an actual Soviet Communist as Comptroller of the Currency for the United States.

So Joe Biden, the supposed “centrist,” has put a confirmed eco-terrorist in charge of BLM and

is attempting (and may have succeeded by the time this column is published) to put an actual Soviet Communist in charge of the American banking system. This is real not a joke. One should not be shocked. Anita Dunn, Senior Advisor to President Biden, has said Mao Tse-tung is “one of her favorite philosophers.” (Washington Times 15 Feb. 2021). Mao is one of the great mass murderers in history. His “Cultural Revolution” slaughtered tens of millions of Chinese as children denounced their parents as decadent and against the Communist regime.

The long-term damage that can be done quietly through the bureaucracy can be just as devastating as the damage we are already seeing play out before us.



Friends and Neighbors,

I wanted to share with you some information on the expansion of property tax relief for seniors, a newly created elder justice hotline, and roadwork taking place in Plainville.

As of October 1, a bill I co-sponsored during this legislative session to expand property tax relief for seniors went into effect.

Per this new law, Public Act 21-84 decreases a previous age requirement for the local option Elderly Tax Freeze Program from 70 to 65 thereby increasing those who are now eligible to receive it.

Under the program, towns may freeze the property taxes on a home whose owner-occupant or his or her spouse meets the minimum age requirement and has been a state resident for at least one year. The freeze continues for a surviving spouse who is at least age 62 when the homeowner dies. Homeowners must also meet the state's Circuit Breaker Program income limits (currently, \$45,800 for a married couple and \$37,600 for an individual).

Continue to the next traffic signal, and take a left onto the I-84 westbound on-ramp.

The work schedule for this repair was on Wednesday, October 6, with a rain date of Thursday, October 7.

Traffic control personnel and signing patterns will be utilized to guide motorists through the work zone.

Q-1) What is the "Network" that is referred to when they talk about Medicare Advantage Plans?

A-1) *The Network is the group of health care providers made up of, doctors, hospitals, and facilities; that participate with the Advantage plans. Some Doctors participate in a number of Networks, some Doctors participate with only a few Networks. It's important to understand your plan's provider network to make sure you get the care you need at the lowest cost.*

Q-2) What is the main difference between a PPO and an HMO in a Medicare Advantage plan?

A-2) *In HMO plans, you generally must get your care and services from doctors, other health care providers, or hospitals in the plan's network (except emergency care, out-of-area urgent care, or out-of-area dialysis) Out of Network services will not be covered by your plan.*

With a PPO plan, you can get your health care from any doctor, other health care provider, or hospital in a PPO's network. You can also go to doctors, other health care providers, or hospitals that aren't in the plan's network, but it usually costs more.

Q-3) Do I have to enroll in Medicare part A as soon as I turn 65?

A-3) *If you have creditable coverage and are eligible for Medicare, you won't receive a penalty if you postpone Medicare enrollment. However, many people do enroll in at least Part A, since it's typically premium-free and may reduce hospitalization costs. If you collect your Social Security Benefits, you will automatically be enrolled in Part A when you turn 65.*

THE CONNECTICUT UNIFORM POWER OF ATTORNEY

EXTRA! EXTRA! READ ALL ABOUT IT! Connecticut has a new Power of Attorney (POA) form that is in effect right now. Is my old POA still good? Will my old POA need to be changed? Does the law require me to get a new POA? I am sure these are just some of the questions everyone may have when first learning about this change in the law. Well, you have come to the right place. Answers to these questions and more are right below... so let's go!

First and foremost if you already have a POA it is still enforceable. This new law does not require you to get a new POA. The new law cleans up some of the deficiencies that have been on the books since 1965 while providing more flexibility for people granting power of attorney. Perhaps the most noticeable change is that the new POA does not need to be designated as "durable". In the past, you would have to specifically state that a POA would survive incapacity. Now it is presumed in the new POA, which makes sense because that is most often exactly when you need a POA.

The powers granted in the new POA are much more customizable than the old version. In the past, when an individual granted Power of attorney to someone and needed that person to undertake some specific act, not listed in the POA form, they would have to amend the POA to specifically state their desires. Even that may not have accomplished what they wanted and then they would be required to provide an additional certification or other required proof. All of which would be very cumbersome and potentially a fatal flaw if the person were to die during the process. Now, the new POA form lists additional functions and provides a catch-all section that can be amended right on the form to include the desired transaction. Essentially, the new POA form consolidates all the precautions

into one form.

So with all these new powers there needs to be extra safeguards. The principal granting the power now has the benefit of naming multiple agents so that each may watch over the other. Also, each agent is tasked with acting in the best interest of the principal. So if one agent is acting in a manner detrimental to the principal they can be stopped. There were obviously too many horror stories going around about people losing everything after granting power of attorney for the legislature to ignore any longer.

Agents will still be afforded the protection of "hold harmless" clauses, which protect them from being sued by unhappy creditors or family members of the principal. However, agents more than ever are liable to the principal if they act in a manner against the principal's desires. The new POA really seeks to provide checks and balance that were not there before.

Financial institutions will also be required to recognize these new POAs under the law. Under the old law POAs were merely looked at as private agreements between people. Now they are a more formalized act of law that must be followed unless the bank has a valid concern that the agent is not acting in good faith and/or there is some attempt at fraud. Again, the legislature was looking to clean up the red tape and streamline transactions where time is of the essence.

So there it is... all of the highlights from the new Connecticut Uniform Power of Attorney. While the new law does not affect old POAs, it certainly gives people a few reasons to go and get a new one. Whether you want to make sure your agent does not have too much power or you want to eliminate some of the red tape it might be time to update your POA. Everyone's situation is unique, so if you are not sure what you may need do not hesitate to contact a licensed attorney. **Happy Thanksgiving!**

Minimally Invasive Dentistry

This may not be a term with which dental patients are familiar, but many dentists use such techniques every day in their practices. Procedures such as remineralization, sealing, inlays and onlays help to conserve healthy tooth structure, which is better for the long-term health of teeth. They allow dentists to perform the least amount of dentistry needed while not removing more of the tooth structure than is required.

One technique used in minimally invasive dentistry is remineralization, which is the process of restoring minerals. It can repair the damage created by the demineralization process, which creates cavities.

Another technique used is sealing. Sealants are usually made of plastic resin and protect teeth from bacteria that cause decay. They fit into the depressions of the tooth and act as a barrier to protect against plaque.

Dentists who use minimally invasive techniques also use inlays and onlays instead of crowns to restore teeth because they do not have to remove as much of the tooth structure as is required with a crown.

When presenting patients with a treatment plan the fact that patients' costs have been managed and that time

in the dental chair will be reduced with more conservative dentistry. With the benefits of all-ceramic restorations often produced with chairside cadcam systems less tooth structure needs to be reduced.

Often dentists have found that the prevention aspect of minimally invasive techniques is good for patients who have undergone such procedures because they adopt healthier lifestyles and pass prevention techniques on to others. Overall, minimally invasive procedures help patients feel good about receiving dental treatment and create a new attitude about dental and oral health care.



General Colin Powell

Powell played key policy role in Bush administration after 9/11 attacks

Gen. Colin Powell, the influential former secretary of state and chairman of the Joint Chiefs of Staff who played a pivotal policy role during the administration of then-President George W. Bush, died Monday at 84 from complications related to COVID-19, his family announced.

"We have lost a remarkable and loving husband, father, grandfather and a great American," his family said in a statement, adding that he was fully vaccinated.

The statement continued, "We want to thank the medical staff at Walter Reed National Medical Center for their caring treatment."

Powell, the first Black secretary of state, served in Bush's Cabinet from 2001-2005, including during the tumultuous years following the Sept. 11 terrorist attacks. The State Department described Powell, a Republican, as being "one of the foremost supporters" of taking "swift military action" against al Qaeda. Powell demanded "immediate" cooperation from Afghanistan and Pakistan in the U.S. effort to hunt down those responsible for the attacks.

By 2003, when the Bush administration's focus had expanded to Iraq, Powell pushed for United Nations inspectors to investigate the claims that Saddam Hussein was manufacturing weapons of mass destruction. Powell presented intelligence to the U.N. in February 2003 that supported the administration's claim that Iraq did have weapons of mass destruction and had the capabilities of producing more. In 2004, though, the State Department said some of the intelligence he presented was "found to be erroneous." Powell, though, according to the State Department, felt military action should not begin "until a large coalition of allies and a long-term occupation plan were in place." Despite his advice, the administration moved toward preemptive military action against Iraq.

While the majority of his term as secretary of state was focused on Afghanistan and Iraq, the State Department said Powell pursued other areas of U.S. foreign policy—including strengthening bilateral relationships with Russia and China—including his efforts to manage the U.S. withdrawal from the U.S.-Russian Anti-Ballistic Missile treaty, and the signing of the Moscow Treaty on Strategic Offensive Reductions in May 2002.

Powell also pushed for international cooperation for North Korea and Iran to halt their nuclear weapons program. Under his leadership, the Bush administration also achieved nonproliferation success in Libya, when it agreed to give up its

nuclear weapons program in 2003, according to the State Department.

Powell, during his time at the State Department, also pushed the Bush administration to increase its commitment to the international fight against AIDS, and helped to secure additional funding.

Powell was born on April 5, 1937 in Harlem, N.Y. His parents were Jamaican immigrants and raised him in the South Bronx.

He attended City College in New York, where he began his military service by joining the Reserve Officer Training Corps (ROTC). Powell graduated at the top of his class with the rank of cadet colonel—the highest ranking in the corps.

He served for 35 years in the military—beginning as a second lieutenant in the U.S. Army. Powell was one of the 16,000 military advisors dispatched to South Vietnam by then-President John F. Kennedy in 1962.

He was awarded the Purple Heart, and later that year, the Bronze Star. Powell served a second tour of duty in Vietnam in 1968 to 1969. He was injured in a helicopter crash. Despite his own injuries, he managed to rescue his fellow soldiers from a burning helicopter and was awarded the Soldier's Medal.

In total he received 11 military decorations, including the Legion of Merit.

Powell's career in politics began during the Nixon Administration, when he worked in the White House Office of Management and Budget. He received his MBA from George Washington University.

Powell, though, went back to military service as a battalion commander in Korea, and was promoted brigadier general, commanding a brigade of the 101st Airborne Division.

In the administration of former President Jimmy Carter, Powell was an assistant to the Deputy Secretary of Defense, and to the Secretary of Energy. He was promoted to major general in 1987, then-President Ronald Reagan appointed Powell to serve as National Security Adviser—a position he held until 1989.

Powell was appointed as Chairman of the Joint Chiefs of Staff on Oct. 1, 1989 by then-President George H.W. Bush, and served in the role until Sept. 30, 1993. Powell was the first Black chairman of the Joint Chiefs of Staff, and the

youngest officer ever to hold the post. During his time in that post, Powell oversaw 28 crises, according to the State Department, including Operation Desert Storm in 1991.

Powell stepped down from the post in 1993 and founded America's Promise Alliance, an organization aimed to help at-risk children, before incoming President George W. Bush nominated him for secretary of state in December 2000.

Former President George W. Bush released a statement on Powell's passing Monday morning.

"Laura and I are deeply saddened by the death of Colin Powell," he said. "He was highly respected at home and abroad. And most important, Colin was a family man and a friend. Laura and I send Alma and their children our sincere condolences as they remember the life of a great man."

Former Vice President Dick Cheney also released a statement on his passing, saying he was "deeply saddened to learn that America has lost a leader and a statesman."

Powell returned to his work with America's Promise Alliance after stepping down from Bush's Cabinet in 2005. Powell, during his retirement, also served on the Boards of Directors for the Council on Foreign relations, the Eisenhower Fellowship Program, and the Powell Center at the City College of New York.

In 2020, Powell spoke at the Democratic National Convention, and offered a full endorsement of Joe Biden for president of the United States.

"Today, we are a country divided, and we have a president doing everything in his power to make it that way and keep us that way," Powell said in a pretaped speech for the convention in August 2020. "What a difference it will make to have a president who unites us, who restores our strength and our soul."

Powell had a wife, Alma, and three children, Annemarie, Linda and Michael.

ALL YOU NEED TO KNOW ABOUT THANKSGIVING

When is Thanksgiving?

Thanksgiving is a Federal holiday celebrated on the fourth Thursday in November in the United States of America. Traditionally, this holiday celebrates the giving of thanks for the autumn harvest.

The tradition of Thanksgiving

The custom of giving thanks for the annual harvest is one of the world's oldest celebrations and can be traced back to the dawn of civilization.

However, it is not commonly a major modern event and arguably the success of the American holiday has been due to it being seen as a time to give 'thanks' for the foundation of the nation and not just as a celebration of the harvest.

The American tradition of Thanksgiving dates back to 1621 when the pilgrims gave thanks for their first bountiful harvest in Plymouth Rock. The settlers had arrived in November 1620, founding the first permanent English settlement in the New England region.

This first Thanksgiving was celebrated for three days, with the settlers feasting with the natives on dried fruits, boiled pumpkin, turkey, venison and much more.

The celebration, however, was not repeated until many years later, when in 1789 George Washington proclaimed Thanksgiving to be a national holiday on Thursday November 26th that year - setting the precedent of the last Thursday in November. Despite this, the holiday was celebrated on different days from state to state and Thomas Jefferson later did away with the holiday.

Thanksgiving didn't become a nationwide holiday until President Lincoln proclaimed the last Thursday in November a national day of Thanksgiving in 1863. Every year following, the President proclaimed a day of Thanksgiving.

Thanksgiving was switched from the final Thursday in November to the next-to-last Thursday in November by President Roosevelt in 1939 as he wanted to create a longer Christmas shopping period to simulate the economy which was still recovering after the Great Depression.

This caused widespread confusion with many states ignoring the change until Congress sanctioned the fourth Thursday in November as a legal holiday in 1941.

INCREMENTAL ISLAM 19

That the status of women is lower than that of men in Islam is undeniable. A case in point is Reliance of the Traveller (ROTT) o4.9: "The indemnity for the death or injury of a woman is one-half the indemnity paid for a man." Similarly, a woman's testimony in court is worth half of that of a man: ROTT o24.7. Additionally, a woman is not considered capable of making her own decisions; rather, she must, throughout her life be managed by a male guardian – her father, husband, brother, uncle or son under a prescribed sequence.

And if you imagine that a woman needs merely

to walk out her front door to breathe the air of freedom, think again. A husband has the right, according to ROTT m10.4, to forbid his wife to leave the home: "It is not permissible for a woman who believes in Allah and the Last Day to allow someone into her husband's house if he is opposed, or to go out if he is averse."

Well, you may think, she could always divorce her husband. Although, if a man desires to divorce a wife, he needs merely to say three times, "I divorce you," and the deed is done, the following excerpt (ROTT n1.1) illustrates the wife's lack of rights:

"Divorce is valid from any:

(a) husband;

(b) who is sane;

(c) has reached puberty;

(d) and who voluntarily effects it."

Until the divorced woman remarries, she retains custody of her young children. Once she remarries though, the custody of those children reverts to the father.

The reason given for that is: "...because married life will occupy her with fulfilling the rights of her husband and prevent her from tending the child."

Next month's column will further discuss a woman's lot in life.



Young At Heart: Heart Healthy Habits For Seniors

When it comes to the impact of age on the heart, there's both good news and perhaps some disheartening news. The not-so-great news: People aged 65 or older are more likely to suffer from cardiovascular disease, the leading cause of death in America. The good news: *It's never too late to improve your heart health!*

Age may be a risk factor for heart disease in older adults, but there are ways to prevent (and even reverse!) some of these risks for heart disease. Through education and proactive steps, preserving your heart health is within your control!

Heart Disease in Older Adults

Your heart is the power supply of your body. This powerful muscle pumps a constant supply of nutrients and oxygen-rich blood to your organs. If the heart stops, your organs and the rest of your body can fail. Over the years, plaque begins to build up in our arteries, also known as atherosclerosis. This buildup can prevent blood flow and lead to a variety of conditions, some of which are listed below.

CORONARY ARTERY DISEASE

Coronary artery disease occurs when plaque builds up in the arteries and restricts blood flow to the heart. About 366,000 Americans die from coronary heart disease each year.

HEART ATTACK

Plaque buildup can break away from the artery wall and create blood clots. Depending on the size of the blood clot, it may block blood flow to the heart and cause a heart attack. Blood clots are the most common cause of a heart attack.

STROKE

Strokes occur when blood flow to the brain is slowed or blocked. Buildup of plaque in the arteries leading to the brain can interfere with the flow of blood to the brain and increase the risk for stroke.

DEMENTIA/ALZHEIMER'S

Plaque can slow or block the blood that nourishes brain cells and prevent the brain from getting enough blood supply in the long term. This can increase the risk of developing dementia or Alzheimer's. According to The Heart Foundation, it is estimated that a third of all cases of dementia, including those identified as Alzheimer's, can be attributed to blood vessel issues.

HIGH BLOOD PRESSURE

As plaque builds up in the arteries, the insides of the arteries become narrower, making it difficult for blood to pass through. The heart must work harder to send blood throughout the body, raising blood pressure. High blood pressure can eventually lead to other consequences, such as kidney disease, heart failure or vision loss.

What Can I Do to Prevent Heart Disease?

Your heart works hard to help you, so you too need to work to protect your heart. There are some heart healthy habits you can start to catch, prevent and even counteract some of the impacts of age on your heart.

KNOW WHEN TO CHECK YOUR BLOOD PRESSURE

Talk with your health care team about how often you should measure your blood pressure. High blood pressure can often go undetected as it usually has no symptoms, so visit your doctor for blood pressure tests as advised.

HEART HEALTHY EXERCISES FOR SENIORS

Your heart is a muscle. If you want it to be strong, you

need to exercise it!

Physical activity has been shown to reverse damage to aging hearts. In a two-year study, individuals aged 45-64 exercised for 150 minutes over the course of four or five workout sessions each week. At the end of the study, the researchers found that physical activity had significantly improved heart health and reduced stiffness in the heart muscle, lowering participants' risk for heart failure. 



Unconstitutional and Un-American Targeting of Concerned Parents & Crackdown on Freedom of Speech by Biden, U.S. Justice Department and CT Democrats

Richard Howells, writing for Forbes, says that the uneven opening of the world economy has a lot to do with the supply bottlenecks.

"Freedom is never more than one generation away from extinction. We didn't pass it on to our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same. Ronald Reagan"

Actually, she picked up the loose ends.

Occasionally a fireman would pop into her upstairs office, but not too often. Sometime Chris felt she had to remind the firemen of her presence by banging her foot on the floor, just to make sure they knew she was there.

Mrs. Aldi said she especially liked to watch as the children made a tour of the fire house. And the fact that she worked at the fire house pleased her young sons. "They thought it was a big deal."

Being a lover of plants, she naturally brought a few samples to the office.

One plant in particular was chosen with firemen in mind. It's an aloe, a plant which has become well known for it's healing qualities, especially burns.

Chris Aldi, better known as "The voice of Plainville" so dubbed by someone some years ago, when she moved to the switchboard at the Town Hall.



the film is lavish, breezy and easy to digest. It transports you into the lives of 4 disparate lovers and throws in a bittersweet conclusion that qualifies for a finely tuned tearjerker both joyous and melancholy.

In present day, Ellie Haworth (Felicity Jones), a journalist is assigned to write a piece about a recently deceased editor. While searching the newspaper's archives with archivist Rory (Nabhaan Rizwan), she discovers a swooning love letter to someone identified simply as 'J' from someone identified as 'Boot'. This arouses her journalistic instincts and starts her on a search for more documents that will hopefully fill in the details and identify these two individuals.

Meanwhile, we are let in on the details behind the old letters as we are transported back to the 1960s. There we meet Jennifer Stirling (Shailene Woodley) as she is transported home by her husband Lawrence (Joe Alwyn) after a hospitalization due to a car wreck that has left her with amnesia. She is unfamiliar with her husband and the details of their life together though a friend assures her she lives a happy existence. Still she feels things aren't quite right. Her concerns are borne out as she comes across a hidden letter that appears to be from someone she is having an affair with. She has no memory of it but it arouses feelings that sends her on a search for more evidence of this mysterious lover identified only as "Boot". As two women existing in two different decades search and discover more of the hidden love letters, we find out that "Boot" is Anthony O'Hare (Callum Turner), a charming young journalist that is introduced into Jennifer's life when he comes to have lunch with the intention of doing an article on the possible political career of her husband. Through the letters we discover how their friendship with one another grows into a romance culminating into a passionate affair. Simultaneously, romantic sparks are beginning to kindle between Ellie and Rory as they delve deeper into the love affair of Jennifer and Anthony.

As we find ourselves intertwined between the budding romances of these two couples decades



removed from one another, we find ourselves drawn to each for different reasons. Director Frizzell gives a nice visual sweep to the world around them as we are exposed to the intimacies of their relationships.

None of this soap opera level excess would be digestible without performances that make you believe what you are witnessing. And this is where the film truly excels. Woodley and Turner ooze the eruptive passion their characters experience and add complexity to their portrayals with nuanced touches that provide a complexity missing in the script. Jones and Rizwan are given far less to work with but manage to provide a sweetness to their relationship that is high up on the likability spectrum. It's fun to watch them slowly come to terms with what is surprisingly developing between them even while we are caught up in the pending tragic events of the relationship they are investigating.

"The Last Letter From Your Lover" doesn't map out any new ground in the annals of romantic dramas but it does make a welcome addition to the genre. Rich, lush and eloquent in execution while emotionally gratifying, it is a successful return to a type of film they just don't make anymore.

Rules of Thumb for Under Cabinet Lighting

One of the biggest must haves when remodeling your kitchen right now is adding under cabinet lighting. What is under cabinet lighting? It's a type of light fixture that is installed directly underneath your cabinets. This light shines directly onto your countertop to give extra task lighting when cooking and prepping.

Benefits of Under Cabinet Lighting

By using under cabinet lighting, you will immediately see fewer shadows because you are not standing between the light and the counter. Your ability to cook and prep meals will feel so much easier because you have the light you need to see well. You'll also have some energy savings because you won't need to illuminate your whole kitchen when you really just need light in the right spot. Using under cabinet lights as mood or night lighting will also enhance that already warm feeling that kitchens have.

Types of Under Cabinet Lighting
There are a couple different options for you to choose from when deciding on your under cabinet lighting. You can choose hard-wired (turn lights on by a pre-existing switch), plug-in or battery-operated. While the hard-

wired option is the most recommended one, it is also the most expensive option because it will require the services of an electrician. The plug-in option utilizes a receptacle on your countertop. If you don't mind seeing the wire and have extra plugs, then this is a great option too. The battery-operated ones that you'll most likely find at the big box stores are a great short-term solution, but there are no guarantees how long they will last – or stick.

Formats

The next thing you'll need to decide before committing to this project is which format of lighting would you benefit from the most. The two most common formats are Light Bars (rectangular) or Puck Lights (small, round disks). The Light Bars are the preferred option because they will more evenly light the countertop. The Puck Lights will have a beam spread around the light itself, but you still may have a few areas that the light doesn't reach. Not all Light Bars are created equal though. The best options are the linkable Light Bars so you can create a continuous run. While you may have to notch out your cabinets to accommodate the equipment, it is impressive to see the light evenly spread around the whole counter.

LED

There is no reason these days to go with anything other than LED under cabinet lights. They emit much less heat than halogens and have the cost saving benefits you will want.

VETERANS DAY NOVEMBER 11, 2021

HISTORY OF VETERANS DAY



Veterans Day, originally celebrated as Armistice Day, was first issued on November 11, 1919, by President Woodrow Wilson

a year after the end of World War I. The purpose of Armistice Day was to honor the fallen soldiers of the Great War for their sacrifice and bravery. Seven years later, in 1926, Congress adopted a resolution requesting that President Calvin Coolidge issue annual proclamations on November 11, making Armistice Day a legal holiday.

In 1945, World War II veteran Raymond Weeks had the idea to expand Armistice Day to celebrate all veterans rather than just the ones who died in World War I. He led a delegation to General Dwight Eisenhower, who was all for the idea. Weeks then organized the first Veterans Day celebration in 1945 in Alabama and every year since, until he died in 1985. In 1982, he was honored by President Reagan with the Presidential Citizenship Medal. Weeks was also named the 'Father of Veterans Day' by Elizabeth Dole.

In 1954, Ed Rees, the U.S. Representative from Emporia, Kansas, presented a bill to establish the holiday to Congress. Eisenhower, who was then the president and also from Kansas, signed the bill into law on May 26, 1954, eight and a half years after Raymond Weeks held the first Veterans Day. After having been through both World War II and the Korean War, the 83rd U.S. Congress — at the urge of

the veterans' service organizations — amended the Act of 1938 by striking out the word 'Armistice' and inserting the word 'Veterans.' With the approval of this legislation on June 1, 1954, November 11 became a day to honor American veterans of all wars.

The National Veterans Award was also created in 1954, first received by Congressman Rees for his support in making Veterans Day a federal holiday. Though the holiday is currently and was originally celebrated on November 11, the day was moved to the fourth Monday of October in 1971 due to the Uniform Monday Holiday Act. Finally, on September 20, 1975, President Gerald R. Ford signed a law that returned the annual observance of Veterans Day to its original date of November 11, beginning in 1978.

The holiday is observed by the federal government on a Friday, if the holiday falls on Saturday, or on a Monday, if the holiday falls on a Sunday. Federal government closings are established by the U.S. Office of Personnel Management. State and local government closings are determined locally and non-government businesses can close or remain open as they see fit, regardless of federal, state, or local government operation determinations.

The United States Senate Resolution 143, which was passed on August 4, 2001, designated the week of November 11 through November 17, 2001, as National Veterans Awareness Week. The resolution called for educational efforts directed at elementary and secondary school students concerning the contributions and sacrifices of veterans.

Cold Weather Safety Tips



Exposure to winter's dry, cold air and chilly rain, sleet and snow can cause chapped paws and itchy, flaking skin, but these aren't the only discomforts pets can suffer. Winter walks can become downright dangerous if chemicals from ice-melting agents are licked off of bare paws. To help prevent cold weather dangers from affecting your pet's health, please heed the following advice from our experts:

Repeatedly coming out of the cold into the dry heat of your home can cause itchy, flaking skin. **Keep your home humidified and towel dry your pet as soon as he comes inside, paying special attention to his feet and in-between the toes.** Remove any snow balls from between his foot pads.

Never shave your dog down to the skin in winter, as a longer coat will provide more warmth. If your dog is long-haired, simply trim him to minimize the clinging ice balls, salt crystals and de-icing chemicals that can dry his skin, and don't neglect the hair between his toes. If your dog is short-haired, consider getting him a coat or sweater with a high collar or turtleneck with coverage from the base of the tail to the belly. For many dogs, this is regulation winter wear. Bring a towel on long walks to clean off stinging, irritated paws. After each walk, **wash and dry your pet's feet and stomach to remove ice,**

salt and chemicals—and check for cracks in paw pads or redness between the toes.

Bathe your pets as little as possible during cold spells. Washing too often can remove essential oils and increase the chance of developing dry, flaky skin. If your pooch must be bathed, ask your vet to recommend a moisturizing shampoo and/or rinse.

Massaging petroleum jelly or other paw protectants into paw pads before going outside can help protect from salt and chemical agents. **Boots provide even more coverage** and can also prevent sand and salt from getting lodged between bare toes and causing irritation. Use pet-friendly ice melts whenever possible.


Like coolant, antifreeze is a lethal poison for dogs and cats. Be sure to thoroughly clean up any spills from your vehicle, and consider using products that contain propylene glycol rather than ethylene glycol.

Pets burn extra energy by trying to stay warm in wintertime. **Feeding your pet a little bit more during the cold weather months can provide much-needed calories,** and making sure she has plenty of water to drink will help keep her well-hydrated and her skin less dry.

Make sure your companion animal has a warm place to sleep, off the floor and away from all drafts. A cozy dog or cat bed with a warm blanket or pillow is perfect.

Remember, if it's too cold for you, it's probably too cold for your pet, so keep your animals inside. If left outdoors, pets can freeze, become disoriented, lost, stolen, injured or killed. In addition, don't leave pets alone in a car during cold weather, as cars can act as refrigerators that hold in the cold and cause animals to freeze to death.



Petit Foundation tourney draws full field of golfers

The Petit Family Foundation's 15th Annual Golf Tournament, held Monday at The Country Club of Farmington, drew large crowds and raised significant funds to assist the foundation's mission.

"We had a good turnout — a full field," said Petit. "Farmington Country Club has taken great care of us these past 15 years. The course was in incredible shape, too. After the flooding we had in August and September, seven holes were underwater at one point. But everything was good for the day of the tournament. The course was in incredible shape; everyone was happy with the condition. It was a nice October day, starting off a little chilly but warming up by the afternoon."

The tournament, which is one of the Petit Family Foundation's largest fundraisers, saw 164 golfers attend and raised in excess of \$60,000 according to Bill Petit. This, he said, puts the tournament's fundraising level back to where it was pre-pandemic. The funds raised will allow the foundation to continue to help foster the education of young people, especially women in the sciences, improve the lives of those affected by chronic illness and aid those affected by violence.

Last year, due to the pandemic, the tournament was limited to 100 people and 25 foursomes and had no auctions or raffles.

"It was just to thank people who had participated in the first 14 years," he said.

This year, Petit said, the tournament was moved from March to the fall due to uncertainty earlier this year about covid-19 regulations. However, the tournament was able to return to its regular format this year.

There were shotgun starts in the morning and afternoon, with 41 foursomes in total. The raffles and silent auctions were back. Prizes were awarded for the longest drive and closest to the pin as well as a hole in one prize and three par three prizes.

Petit said that people came from near and far to help support the Petit Family Foundation.

"We had a group of about a dozen Foundation supporters come from the Philadelphia area," said Petit. "We also had some folks come in from Massachusetts, New Hampshire and New York."

Petit said he is grateful to those who have supported the foundation as the tournament reached its 15 year milestone. He thanked Cheri Ziebka for chairing this year's golf tournament and Bernie Lidestri for chairing it in past years.

The Plainville Historical Society will present Kevin Johnson as William Webb, an African-American Civil War soldier from Connecticut at 29 Pierce Street, Tuesday, November 16th at 7 P.M. Private Webb was an actual soldier, a native of Hartford. He was recruited in 1863 and served in the Twenty-Ninth (Colored) Regiment, Connecticut Volunteer Infantry in several

battles in Virginia. Johnson's presentation of Webb is told from an emotional and exciting first-person perspective that vividly illustrates the struggle of the African-Americans in the Colored Infantry during the Civil War. He tells of his early life in Hartford, his recruitment and training and the trumatic final battles of the Civil War. 




Plainville Football Team Season's Midway Point

Record: 4-1

Verdict:

Plainville football has sneakily put up a good season for the Herald-Press area.

The Blue Devils grinded out wins over South Windsor, Lyman Hall, Bristol Eastern and Lewis Mills, maxing out at 27 points scored on offense. Despite a 91-120 point scored to allowed differential (due to a 48-0 loss to Bloomfield) the Blue Devils are in a good position to finish strong.

A rushing mix of Ky McGraw and Michael

Bakaysa, with Bakaysa also able to sling it down field, has worked well, but the real story with Plainville comes from the defensive effort. In its win over Eastern, the Lancers remarked on their strong play despite Plainville being "killed" by the big play early in the season.

They aren't flashy, and they won't have any players blow out the scorebook with extreme numbers. They'll grind out a win with a balanced approach on offense and will keep the game competitive on defense, but without a complete stat sheet (MaxPrep was not updated as of Sunday) it's hard to see where they thrive in regards to rushing the passer or locking down in the secondary.

But, don't count out Tim Shea's boys. I have a feeling they can finish strong with a weak schedule ahead.

Blue Devil Girls Volleyball Turnaround

The Blue Devils' second year head coach has led this year's squad to a 11-4 record through 15 games. During the 2020 season, Plainville finished 1-11 during Caponigro's first season at the helm.

Now one of the best teams in Class M, Caponigro's vision is starting to take shape when she first took over the Blue Devils' coaching duties.

Caponigro had to learn on the fly during her first season as she barely had any time to get to know her roster beforehand, Alle replaced Bob Moffo, who coached Plainville the three seasons prior, in sudden fashion.

"Last year was tough when I walked in the day before the first game and we just had to hope for the best," she said "That's tough to walk into. This year we know each other, they know how I coach, I know how they play, it's easier to adjust mid-game in those types of situations when you know each other and you trust each other as a team."

That familiarity has translated on the court this fall as the Blue Devils are in the midst of their best season since 2016, when they won 20 games. Plainville advanced to the quarterfinal round of the Class M tournament that year before falling to Seymour 3-2.

Having won a combined seven games from 2017-20, Caponigro's coaching decisions have clearly made an impact for the Blue Devils this time around.

"Making them all be able to play all the way around. I think was a big improvement in their morale, which turns into a better improvement on the court and in games." she said.

Caponigro credited three seniors in Wiktorija Galazyn, Lilly Wazorko and Samantha Thompson as players who have had key roles in Plainville's breakout season.

Galazyn for sure, Lilly Wazorko is our middle hitter and she's a just a big presence out there, and she's a big supporting out there.' Caponigro said. "Sammy Thompson does a great, great job for us keeping everybody on track and making sure that they're keeping their energy up when they're getting a little bit down on themselves. I think people overlook that player on the court, but she's the most important one out there."


